Post August 1st

Dear friends, *Deep Throat* was a huge success earning a staggering (at that time) \$25 million. In the documentary *70s Fever*, David Cassidy connected the film to the “sexual revolution”, demonstrating the power of the big (Cinema) and little screens (TV) to influence the consciousness. The development of cable and satellite television in the 1970s allowed for more channels and facilitated businesses to direct programs to specific audiences. In the documentary, David Cassidy also related that by the early 1970s “more than 52% of households had color TV”, compared to the 3% in 1964. Moreover, in 1972 the TV stations were able to produce original programming when the government deregulated the industry. With this development, both the “*Light*” and “*Shadow*” possessed a “tool” to inspire or influence the collective consciousness *en masse*.

Regrettably, as the “*Shadow*” held the market on greed, “his” influence dominated the commercial advertising, and the public was slowly influenced to become more and more material. Through manipulation, the “*Shadow*” induced the network executives to constantly tantalize the public with products, together with the subliminal message that to be successful they must purchase the products as soon as possible. In addition, the TV could sway people to join groups and adopt certain mannerisms. We see this in the fads like the Pet rock, jogging, and fashions that spread like wildfire among TV viewers in the 1970s.

Unfortunately, the greatest power the TV had was to influence public opinion on political issues, which could cause huge shifts in the emotions of the nation and therefore the consciousness. During the early 1970s, the nation’s focus was on the Vietnam War, which as I said was entering Americans living rooms every night through the reports on the nightly news. This brings me back to the most damaging event to the consciousness of the Baby Boomers in the ’70s decade.

To recap, as President Nixon began pulling out troops from Vietnam in 1969, I wondered why the war dragged on until the fall of Saigon in 1975. Having identified Richard Nixon as the unwitting tool of the “*Shadow*”, I considered whether his reducing the troops in Vietnam meant that he was on the side of the “*Light*.” Answering that question was not easy, because it is a complicated issue and involved understanding the effect on the consciousness in America during those troubling times. Above I recounted the events in Vietnam from the perspective of Richard

Nixon and Cambodia, now I want to return to the Vietnam War overall. With so many soldiers dying in the late 1960s, when that number dropped to below half the number in 1970, everyone began to see an end to the war. However, as the author of the entry explains, the reason was because the troops were relocated from the border, which was where the heaviest fighting was, and therefore the most casualties. From the political standpoint, as stated, the communists were using Cambodian soil as a base to attack Vietnam, which Sihanouk tolerated in order to keep Cambodia out of “a wider regional conflict.” In 1969, the US put pressure on him to withdraw his tacit support of the communists. When Sihanouk caved, Nixon “took the opportunity to launch a massive secret bombing campaign, called Operation Menu, against their sanctuaries along the Cambodia/Vietnam border.” Since this was a violation of Cambodia’s “neutrality”, which America claimed to support, the President felt obliged to reassure Sihanouk. So as the author of the entry records, in April 1969 Nixon wrote to Sihanouk stating that the US “respected the sovereignty, neutrality and territorial integrity of the Kingdom of Cambodia.”

Seemingly then in 1969 President Nixon was interfering in the affairs of Cambodia, which played into the “*Shadow’s*” strategy as it gave the Khmer Rouge the opening it needed, but as the world did not experience the results of this until the late 1970s, I will move on. President Nixon became a tool for the “*Shadow*” in the early years of the decade because he caused a change in perception of the public. Up until the Vietnam War, soldiers returning from any war were greeted as conquering heroes. However, due to the anti-war sentiment, not to mention the media reports of the Mỹ Lai Massacre, in the early ’70s, the young men returning from Vietnam were spat at and called “baby killers.”

Ever since the Vietnam War ended, many veterans have complained they did not have a clearly defined objective in fighting the war. For instance, soldiers often reported being ordered to fight to take ground only to be told to withdraw from it later. Not surprisingly, as lives were lost in taking the ground, this was extremely disheartening, as well as confusing. President Nixon’s policy of Vietnamization, in that the US troops were replaced by South Vietnamese forces, only added to the troops confusion. According to Nixon’s entry, “From 1969 to 1972 troop reduction in Vietnam was estimated to be 405,000 soldiers.” As more and more of these young men were sent home, the Viet Cong gained even more ground. Therefore, in the eyes of many Americans, the veterans returned home not as conquering heroes, but as aggressors that were sent packing by the rightful owners of Vietnam. Ultimately, this treatment aided in leading to alcoholism and drug addiction, stopping the Baby Boomers’ momentum of bringing justice and peace to the world in its tracks.

I can remember as a teenager being struck by the lyrics of Paul Hardcastle's song "19", which proposed the average age of the men serving in Vietnam was 19. Although some people dispute this, I doubt if many of the men serving were much older. As stated, the age of spiritual decision is 21 and to place young men in a situation of fear and death affects them spiritually. This situation is further exacerbated when 19-year-olds are ordered to "police" their own citizens. David Cassidy laments in the documentary *70s Fever*, how at Kent State "nineteen-year-old American national guardsmen were shooting at nineteen-year-old American students." In individuals under the spiritual age of consent, any violence they perpetrate leaves a scar on their consciousness, which they will have to work through eventually. Notwithstanding this, the most damaging aspect of the Vietnam War was the young soldier's treatment by their own countrymen and women, as it so seriously damaged their psyche that many of them simply withdrew from society altogether, becoming homeless. To summarize then, by the time President Nixon pulled all the U. S. forces out of Vietnam and stopped the draft in 1973, it was too late, because the damage had already been done to a large percentage of the Baby Boomers, who were exposed to the three-great "lights" (JFK, RFK, and Dr. King) of the 1960s.

To attract volunteers to replace the draftees, military pay was increased and television advertising for the United States Army began for the first time. In 1973 peace talks began in Paris, but alas, bringing peace to Vietnam was not as simple as the two leaders coming to terms. Richard Nixon's entry relates that in December of 1972, the president "approved Linebacker II, the codename for aerial bombings of military and industrial targets in North Vietnam." Nonetheless, it appeared that peace was possible when both sides signed the Paris Peace Accords the next year. Unfortunately, this "treaty" did not allow for the fact that between 145,000 and 160,000 Viet Cong soldiers were still stationed throughout South Vietnam. Despite this, President Nixon continued to pull the US out of Vietnam and by 1973, the number of American troops had dropped from 543,000 to zero. That year however, the withdrawal from Vietnam was soon pushed into the background, when rumors began to circulate about Nixon's involvement in a break-in dubbed "Watergate." Dear friends, as we know withdrawal of American troops from Vietnam did not alleviate the tension in the country, because in the summer of 1973, America was torn apart with President Richard Nixon's involvement in the Watergate break-in. I am not going to discuss the actual break-in or the long-drawn-out investigation by the two Washington Post reporters here, at this time I am only concerned with the effect on the consciousness of America. Richard Nixon's resignation on August 8, 1974, caused a drastic shift in the nation, dividing the people. The main division arose from the newly incumbent President, the former Vice President Gerald Ford, granting Richard Nixon a full and free pardon from prosecution a month later. As there is an innate need for justice inborn in each of us, the pardon caused many people to lose faith in their country's government. Even though Gerald Ford's contribution to both Great Spirit-Mind's plan and the "Shadow's" agenda, was peripheral at best, I still want to review the historian's summary of his presidency.

The unusual chain of events that lifted Ford to the Oval Office began in 1972 when operatives connected to President Richard Nixon's (1913-1994) re-election campaign broke into the Democratic National Committee headquarters at the Watergate Hotel in Washington, DC. A number of high-ranking Nixon administration officials knew about the break-in, and the president himself took part in efforts to cover up the illegal activities that became known as the Watergate scandal. As the scandal came to light, Vice President Spiro T. Agnew (1918-1996) resigned from office in October 1973 over unrelated charges of accepting bribes and evading taxes. Nixon used his power under the 25th Amendment to the U.S. Constitution to appoint Ford as his new vice president. The well-liked and respected

Ford was easily confirmed by Congress and took office on December 6, 1973... Shortly after taking office, Ford pardoned Nixon for any crimes he may have committed as president... Some critics charged that Ford issued the pardon as part of a pre-arranged deal to reach the Oval Office. But Ford insisted that the nation's future hinged on ending the ordeal of Watergate and beginning the process of healing. During the remaining two years of his presidency, Ford faced a domestic energy crisis and a weak economy marked by high inflation and unemployment. He also struggled to work effectively with a heavily Democratic Congress. In fact, Ford vetoed 66 pieces of legislation that conflicted with his basic philosophy of fiscal conservatism. Ford's foreign policy generated both successes and failures. Unable to convince Congress to approve further military aid to South Vietnam, he could only watch as the country fell to North Vietnamese Communist forces in 1975. Later that year, however, Ford helped reduce tensions with the Soviet Union by signing the Helsinki Accords, which were meant to strengthen the relationship between Western nations and the communist countries of Europe.

Disillusion with Government had begun with the revelations of the Pentagon Papers in 1972, revealing that the Johnson Administration had lied to the American public about the progress and prospects of the Vietnam War. The overwhelming message I got from watching Ken Burns and Lynn Novick's documentary *The Vietnam War* on PBS, was that good people were caught in an impossible situation. It was clear to me that the "Shadow" used the American leaders' egos and counterfeit-spirits to manipulate them into continuing a war. Unfortunately, none of them realized they were being used for "his" agenda. One of the saddest scenes in the documentary for me, was when over 800 members of the VVAW (Vietnam Veterans Against War) threw their medals over a barricade onto the steps of the US Capitol. To reiterate, the revelations about the Vietnam War from the Pentagon Papers, gave rise to the wild abandon of all society's mores. The people's discontent was exacerbated further when Gerald Ford pardoned Richard Nixon, because it was seen as – one law for the rich and powerful and another for the rest of the people. This resulted in a further alienation from traditional society by the Baby Boomers, which began escaping reality any way they could, with many of them, as stated, turning to the recreational drugs of cocaine and amphetamines. However, according to the *70s Fever* documentary, the most prevalent drug used during this time, was the legally prescribed anti-depressant Valium, which had reached 2.5 billion tablets sold by 1978. Gerald Rudolph Ford Jr. 1913 - 2006

According to his entry on Wikipedia, Gerald Rudolph Ford Jr. was born Leslie Lynch King Jr. on July 14th in Omaha, Nebraska, but raised in Grand Rapids, Michigan. “He attended the University of Michigan, where he played for the school's football team, before eventually attending Yale Law School. Afterward, he served in the U.S. Naval Reserve from 1942 to 1946. Ford began his political career in 1949 as the U.S. representative from Michigan's 5th congressional district, serving in this capacity for nearly 25 years, the final nine of them as the House minority leader. In December 1973, two months after Spiro Agnew's resignation, Ford became the first person appointed to the vice presidency under the terms of the 25th Amendment. After the subsequent resignation of Nixon in August 1974, Ford immediately assumed the presidency.

“Domestically, Ford presided over the worst economy in the four decades since the Great Depression, with growing inflation and a recession. In one of his most controversial acts, he granted a presidential pardon to Nixon for his role in the Watergate scandal. Foreign policy was characterized in procedural terms by the increased role Congress began to play, and by the corresponding curb on the powers of the president. Ford signed the Helsinki Accords, which marked a move toward détente in the Cold War. With the collapse of South Vietnam nine months into his presidency, U.S. involvement in the Vietnam War essentially ended.

“In the 1976 Republican presidential primary, Ford defeated Ronald Reagan for the Republican nomination, but narrowly lost the presidential election to the Democratic challenger, Jimmy Carter.

“Following his years as president, Ford remained active in the Republican Party, but his moderate views on various social issues increasingly put him at odds with conservative members of the party in the 1990s and early 2000s. He also set aside the enmity he had felt towards Carter following the 1976 election and the two former presidents developed a close friendship. After experiencing a series of health problems, he died in Rancho Mirage, California in 2006. Surveys of historians and political scientists have ranked Ford as a below-average president, though retrospective public polls on his time in office were more positive.”

Post August 3rd

Dear friends, apart from the disillusionment of the government, in the early 1970s the American people were dealing with a crippling economic crisis with large numbers unemployed and a shortage of gasoline. Nixon’s support for Israel during the Yom Kippur War in October 1973 had brought on this crisis, as it seems that the Arab oil producing countries punished the West for its support of their enemy. As I knew very little of this war, I looked it up on Wikipedia, and under the entries for Yom Kippur and the Oil Crisis of 1973, I found that it occurred during the Holy Islamic holiday of Ramadan. Once again, the tiny state of Israel was attacked by a coalition of Arab nations, making it the “fourth” time Israel had fought since becoming an independent state. On this occasion, the Arabian coalition chose to attack Israel on the “holiest day in Judaism”, Yom Kippur, violating the previous “cease-fire lines.” Evidently, the Arab nation’s goal was to retake the Sinai and the Golan Heights, “captured and occupied by Israel since the 1967 Six-Day War.

An unforeseen consequence of this fourth Arab-Israeli conflict was its effect on the rest of the world, through the oil crisis, which as stated arose because of the Nixon’s support for Israel. The historical facts are that when the “members of the Organization of Arab Petroleum Exporting Countries or OAPEC”, saw that America was providing support for Israel through arms, they “proclaimed an oil embargo.” It was not until the beginning of 1974, January 18th when Secretary of State Henry Kissinger “negotiated an Israeli troop withdrawal from parts of the Sinai” that the situation eased. Kissinger’s “promise of a negotiated settlement between Israel and Syria was sufficient to convince Arab oil producers to lift the embargo in March

1974.” Although Israel left the Golan Heights by May, the Arab oilmen had tasted the power they could wield. As a result, the “*Shadow*” was able to manipulate their false egos to use the price of oil to increase their personal wealth. According to the entry, “Independently, the OPEC members agreed to use their leverage over the world price-setting mechanism for oil to stabilize their real incomes by raising world oil prices.” Despite Europe taking the initiative, by reducing consumption and researching renewable energy sources, the die was cast, and the price of oil skyrocketed throughout the seventies. The author observes that these two events has led to this time being “regarded as the first event since the Great Depression to have a persistent economic effect.” Since, as the entry reports, this coincided with the “1973–1974 stock market crash”, the scene was being set for the “*Shadow*” to take control.

From the consciousness perspective, the quote that “the OPEC members agreed to use their leverage over the world price-setting mechanism for oil to stabilize their real incomes by raising world oil prices”, is illuminating. When we consider how much the world depends on oil to function, this action of greed would have far-reaching effects, because it impacted the returning GIs from Vietnam. These young men came home to not only slurs and insults, but to a country in an economic crisis with no jobs to offer them. All these consequences reveal why the “*Shadow*” manipulated Nixon into supporting Israel in the Yom Kippur War.

The Oil crisis of 1973 was the final straw for many Baby Boomers caught up in the Vietnam War. As stated, many of them were suffering from PTSD, also known as Soldier’s Heart, Shell Shock, Battle Fatigue, and Combat Stress Reaction (CSR), consequently, they needed counseling. Unfortunately, PTSD (Post Traumatic Stress Disorder, or as it is now called PTSS for Syndrome instead of disorder) was not officially recognized until 1980. At this time (1970s), these young men were left to their own devices, which was a tragic mistake, because, as stated, while in Vietnam many of them were introduced to the highly addictive and destructive drug heroin.

Drug trafficking was probably the most efficient way the “*Shadow*” found to corrupt the Baby Boomers and once again, “he” used organized crime. In America, organized crime was dominated by the Sicilian Mafia, but before Heroin gets to the US, it must be refined from its natural form, opium. So, before I discuss this development from the consciousness and spiritual aspect, we will take a moment to review what Wikipedia has to say about the Heroin drug trade from where the opium is grown. I found the most relevant information in the entry for the “Golden Triangle”, which states that it consists of “an area of around 350,000 square kilometers that overlaps the mountains of four countries of Southeast Asia:

Myanmar (Burma), Vietnam, Laos, and Thailand.” Today we need to add Afghanistan and Pakistan in the “triangle” as “it has been one of the most extensive opium-producing areas of Asia and of the world since the 1950s.” Interestingly, Asian drug traffickers found it hard to break into the US “drug world”, as the Mafia controlled the market, but after they were caught and sent to prison “during the 1970s”, and met American drug traffickers, they gained “access to individuals and organizations distributing heroin at the retail level.”

Obviously, in America, drug trafficking was the exclusive domain of the Mafia, so I did some research on this aspect of them. Initially it was difficult to find articles that specifically identify the Mafia as the main dealers in the drug trafficking of Heroin. Nonetheless, I found the facts below from an article on the web that gives us a pretty good idea of how it began in the 1950s. Under the title *How the Sicilian Mafia flooded the US with Heroin*, we read:

*For over fifty years the Sicilian Mafia has been one of the biggest operators in the international heroin trade... From October 10 to 14, 1957 Joseph Bonanno chaired an important meeting between Sicilian-American mobsters and Sicilian Mafiosi at the Grand Hotel des Palmes in Palermo, Sicily... The Sicilians could operate in the US under the protection of the American mob families, and import, and distribute, the drugs. The American bosses would get a cut from these operations... April 9, 1984, law enforcement carried out raids throughout the United States. Four-hundred federal agents and police officers arrested twenty-two suspects... Salvatore Catalano was among the arrested. The Pizza Connection trial (so called) because pizza parlors were used to distribute the drugs and launder the money, revealed that over \$1.5 billion worth of heroin was imported. The money moved through wire transfers, private airplanes, and using men who would travel the world with a suitcase filled with drug dollars. The trial, lasting seventeen months cost more than \$50 million. The so-called bosses of the Pizza Connection were all found guilty, including Catalano who was sentenced to 45 years in prison.*

One point five billion dollars sounds like a fortune; however, some have estimated that the Sicilian Mafia has made as much as 8 billion from drug trafficking. Whenever I consider the War on Drugs, I am reminded of Prohibition where organized crime made a fortune supplying illegal liquor to Americans. Although the Sicilian Mafia began in New York, it eventually replaced the bootleggers expanding across the country. It was through the money made from Prohibition that organized crime managed to gain such a strong foothold in America. After Prohibition was repealed, the Mafia simply went back to their former activities of gambling and “protection” rackets. They took gambling to the “*enth*” degree when they founded the gambling Mecca of Las Vegas.

Prohibition should have been a cautionary tale for anyone thinking of infringing on a person’s freedom, even if they believe it is for “their own good.” Someone will

always be there to take advantage, supplying the forbidden “fruit” and getting very rich and powerful in the process. I firmly believe that if there was no money to be made by providing drugs, then the “crooks” would not bother. Consequently, the last thing the “*Shadow*” wanted was the legalization and taxation of drugs. Again, from the consciousness perspective, the energy behind organized crime simply developed and grew into the drug trafficking business, resulting in the illegal drug trade. Drug trafficking has had devastating effects on many Baby Boomers, particularly the veterans that became heroin addicts and subsequently homeless.

Tragically, corrupting the Baby Boomers with drugs was not the most devastating tool the “*Shadow*” used in the 1970s to retake control, because it was during the ’70s that “he” launched “his” most effective method to alter the mass consciousness, extreme fear. This was a relatively easy thing for the “*Shadow*” to achieve, as “he” merely influenced certain individuals to use terror to achieve their goals. In this way, the title for the 1970s, “Decade of Death”, represents the death of people’s conception that other nation’s wars could not reach their homeland. Dear friends, a brief look at the number of bombings, kidnappings and hostage taking in the 1970s reveals the shift in the energy. These particular tools of the “*Shadow*” were first used in the UK in 1971, with an inexplicable bombing in the tallest building in London, the Post Office Tower. Unfortunately, it proved to be just

the beginning, as seen below in the list of bombings and terrorist incidents that occurred on British ground during the 1970s:

1. 31 October 1971: A bomb exploded in the Post Office Tower, resulting in the building's permanent closure to the public.
2. 8 March 1973: The Provisional Irish Republican Army (IRA) conducted its first operation in Britain, planting four car bombs in London. Two bombs exploded, killing one person and injuring 180 others...
3. 27 March 1974: A bomb placed by the Provisional IRA exploded in a garbage can at the top of an escalator in a crowded exhibition hall, Earl's Court. 20,000 people were attending the Daily Mail Ideal Home Exhibition at the time. 70 were injured, 4 people lost limbs.
4. 17 June 1974: A bomb exploded at the Houses of Parliament in London, causing extensive damage and injuring 11 people.
5. 7 November 1974: An off-duty soldier and a civilian were killed when a bomb was thrown through the window of the Kings Arms pub in Woolwich, and 28 people were injured...
6. 21 December 1974: A bomb was defused in Harrods department store in Knightsbridge, London, (A second bomb was defused in the King's Arms public house in Warminster, Wiltshire).
7. 28 August 1975: Seven people were injured when a bomb exploded in Oxford Street, London. A telephone warning was issued to *The Sun* newspaper five minutes before the explosion.
8. 5 September 1975: Two people were killed and 63 injured when an IRA bomb exploded in the lobby of the Hilton hotel in London.
9. 6–12 December 1975: Four IRA members held two hostages in the Balcombe Street Siege.
10. 30 March 1979, Shadow Northern Ireland Secretary Airey Neave was killed as he left the House of Commons car park by a car bomb planted by the Irish National Liberation Army (INLA) in 1979.

People's sense that no one was safe anywhere, grew exponentially after the Munich Olympics in 1972. The world watched live on television in disbelief, as terrorists from Black September took Israeli athletes and several coaches hostage. The author of Wikipedia's entry for the Munich Massacre encapsulates the event by relating that "By the end of the ordeal, the terrorist group had killed eleven Israeli athletes and coaches and one West German police officer." The terrorists did not get off Scot free, as "Five of the eight members of Black September were killed by police officers during a failed rescue attempt. The three surviving terrorists were captured and were

later released by West Germany following the hijacking by Black September of a Lufthansa airliner.”

Talking of hijacking reminds me of one of the most well-known instances, the hijacking of Air France Flight 139. The perpetrators were a combination of two terrorist’s groups, the Popular Front for the Liberation of Palestine and the Red Army Faction. As the latter was a West German terrorist group, I was a little surprised but as the “*Shadow*” was behind it, I should have realized that “he” would connect groups with the same mandate, namely, to create terror and chaos. This hi-jacking ended in the daring rescue of the hostages by Israeli commandos. I found the historical facts of this on its *Encyclopedia Britannica’s* page, which explains that after releasing the passengers deemed unconnected with Israel, they demanded the “release of 53 militants” in prison throughout the world for the remaining hostages. Unwilling to give into blackmail, Israel’s answer was to “dispatch four Hercules C-130H planes”, which was transporting up to 200 Israeli commandos. Dear friends, during the 1970s, one of the most virulent groups to spread terror through bombs was the West German, Left Wing Baader-Meinhof Group, or their preferred designation the Red Army Faction. Amazingly, this West German terrorist group that was formed in 1968 by Andreas Baader and Ulrike Meinhof, were also bank robbers. Excerpts from *Encyclopedia Britannica's* page for the Red Army Faction reveal just how devastating these groups were to the public's peace of mind. Throughout the 1970s, the group engaged in "bombings and arson especially of West German corporations and businesses." In addition, they targeted "West German and U.S. military installations in West Germany. They also kidnapped and assassinated prominent political and business figures." The author tells us that by the mid-1970s, "the group expanded its scope outside West Germany" and as Entebbe attests, "occasionally allied itself with militant Palestinian groups."

In the 28 years this terrorist group was in existence, it is directly responsible for the deaths of 34 people, who they specifically targeted. However, their "operations" frequently resulted in collateral damage, with many, many, more being killed or injured. According to their entry on Wikipedia, "There were three successive incarnations of the organization." The first "consisted of Baader and his associates." RAF's "second generation" formed following the recruitment of "several former members of the Socialist Patient's Collective." We know that this version was the deadliest because they "operated in the mid to late 1970s." Finally, the "third" and last version of the Red Army Faction "existed in the 1980s and 1990s."

Even though the U.S. was not directly targeted by the terrorist groups in the 1970s, American consciousness was still affected. Consequently, as the level of fear and despair grew, the Baby Boomers sought more and more ways to escape. Yet, by the mid-'70s, drugs and sexual experimentation was no longer providing sufficient release from the tension and the Baby Boomers started looking for leaders to guide them again. Unfortunately, the "leaders" who stepped forward to take up the role were unconsciously tools of the "*Shadow*", presenting themselves as gurus, who claimed to hold the answers to life. Naturally, to receive these answers all the gurus required was complete surrender of the seeker's freewill to them. As the need for guidance grew the number of sects multiplied. Until according to the *70s Fever* documentary, by the mid-1970s there were 300 fringe religious groups operating in San Francisco.

Scenes of the fall of Saigon flashing across TV screens, shattered the illusion of American invincibility. Although it may not have appeared to at the time, the fall of Saigon caused a serious backlash in the psyche of the Baby Boomers. Once again, the “*Shadow*” took advantage of this by inciting even more hedonistic behavior. One of “his” most successful ways was initiating the opening of two very controversial clubs, Studio 54 and Plato’s Retreat. I could not find a specific page in *Encyclopedia Britannica* for Studio 54 in Manhattan but on the page for Discos, I found the excerpt below:

*Steve Rubell created the chic disco of the 1970s, taking the energy of earlier underground New York City clubs like the Haven and the Sanctuary and mixing it with the 1960s European concept of le discotheque, the classy nightclub where one danced to records rather than live bands. At Studio 54 the beautiful and the damned gathered to take drugs and dance to the new post-Philadelphia soul groove that came to be known as disco.*

Turning to our second nightclub “Plato’s Retreat”, I could not find a reference to it in *Encyclopedia Britannica*, so I went on-line and learned that Larry Levinson opened it in 1977 and that it was located in the Ansonia Hotel, of the Continental Bath’s fame. However, Plato’s Retreat was not a gay club, according to its entry on Wikipedia, “Levenson strictly prohibited sexual activity between males but welcomed lesbianism. Drugs, including alcohol, were not allowed, though they were frequently used despite the rule. During its heyday, Plato’s Retreat was considered the world’s most infamous sex club and was popular with many celebrities, porn stars, and well-to-do couples.”

Even though Studio 54 did not engage in sex escapades, it did promote the use of drugs as in the infamous enormous figure of the man in the Moon “snorting” cocaine. As the publicity for these two clubs increased, a reaction began to stir within the Baby Boomers. Very slowly, the “Silent Majority” as they were known in the documentary *70s Fever*, distanced themselves from young people. Yet as parents they became increasingly concerned with the hedonistic culture’s influence on their children. Post August 15th

Dear friends, before I make the link between events in Uganda during the 1970s and the next phase of our mission, let me explain why I have chosen to break a self-imposed cardinal rule in sharing this on the Forum. From the outset, we wanted to separate the *Know Thyself Initiative* from our work with the I.D.E.A. Foundation for the Benefit of Humanity. However, we were shown that the Seeds of Compassion Movement needs to be shared across the world, simply because it has the potential to bring relief to so many.

As many members know, we have been involved with our administrator, Wandera's God's Grace orphanage. Wishing to become self-sufficient he came up with the idea of raising money to erect a hen house to not only feed the children and pay for their education, but also enable him to build a new orphanage on his own land. We were so impressed with his selflessness and dedication that we were moved to help by personally covering the shortfall for the project and purchasing the land from a small inheritance Craig received. Even so, unbeknownst to us our work with this remarkable young man triggered the next phase of our 30-year mission, which was the Seeds of Compassion movement. But first, how was this connected to Uganda in the 1970s.

Uganda became a household name when the Israeli commandos rescued the hostages in the Entebbe raid. At the time, Uganda was ruled by the dictator Idi Amin. Learning that Idi Amin helped the hijackers, reminded me that he was one of the most vicious and some would say mad dictators of the 1970s decade, providing another good reason for the treatise' sub-title "Decade of Death." Although, I mentioned this volatile megalomaniac dictator earlier in respect to the British Empire becoming the British Commonwealth, in light of our recent involvement with Uganda, we couldn't ignore the synchronicity of this entry.

I found some interesting facts about Idi Amin on his Encyclopedia Britannica page, which relates that he came to power through a military coup he orchestrated on January 25th, 1971, appointing himself president and "chief of the armed forces." He upped that to Field Marshal in 1975, then in the ultimate act of dictatorship, a year later he decreed that he was president for life.

For me, Idi Amin was most famous for "expelling" the entire Asian population of Uganda, which resulted in the UK needing to take in the refugees. What I was unaware of at the time, since I was only 16, was the forced exile resulted in a "breakdown of Uganda's economy." Throughout his presidency, Amin had resisted any kind of delegation of his authority, ruling as an autocratic dictator. Apart from removing all the Asians from Uganda, Amin alienated himself from the West, by not only "publicly insulting" the leaders, but by also aligning with two countries that were known supporters of terrorism, Libya and Palestine. Up until then, Uganda had been on friendly terms with Israel and the West. The author of his page notes that the Dictator was extremely volatile and subject to "abrupt changes of mood, from buffoonery to shrewdness, from gentleness to tyranny." As for his role in the Entebbe hi-jacking, the author leaves us with no doubt, when he or she reports that "he was personally involved in the hijacking of a French airliner to Entebbe." Nonetheless, the page's summation of Amin is the most damning as it reports:

He also took tribalism, a long-standing problem in Uganda, to its extreme by allegedly ordering the persecution of Acholi, Lango, and other ethnic groups. Amin came to be known as the "Butcher of Uganda" for his brutality, and it is believed that some 300,000 people were killed, and countless others tortured during his presidency.

Idi Amin's downfall came from attacking Tanzania in October 1978. Unfortunately, by then his own people were splintered, as such, "Ugandan nationalists" joined the Tanzanian troops to prevail against Idi Amin's Ugandan army. When the Tanzanian

army began closing in on Uganda's capital Kampala on April 13th, 1979, "Amin fled the city." Initially, he fled to Libya, but later "settled in Saudi Arabia."

Although Idi Amin was a megalomaniac, what happened in Uganda had been seeded more than five decades earlier by the "*Shadow*." Previously, I listed which African countries were aligned with the Central Powers of Germany and Kaiser Wilhelm (II) in the First World (Great) War, reporting that South African Apartheid was a direct result of the country's alliance with the Kaiser. This was also the case with Uganda. Without excusing Idi Amin's treatment of his people, in one way the Ugandan president was also a victim of the energy of the "*Shadow*" or the "prince of this world", through his country's allegiance to the "*Shadow's*" side in the First World War, which tainted Uganda's energy. Tragically, as we shall see later, South African and Ugandan actions were not the worst examples of the consequences for their countries' allegiances in World War I.

From the above information, we know that Uganda was seeded with the energy of the "*Shadow*" long before Idi Amin came to power. Unfortunately, although Uganda has slowly begun to recover economically, the majority of its people still suffer, particularly orphaned children. As many members know, we have been involved with our administrator, Wandera's God's Grace orphanage, primarily helping him purchase a piece of land to build a new orphanage. In order to fund it, he came up with the idea to erect a hen house to not only feed the children and pay for their education, but also enable him to build a new orphanage on the new land. All was going well, until his landlord announced that he wanted the land and buildings that Wandera was renting back because his family was returning to the area, giving him notice to be out by November 1st. This added a new level of urgency in finding temporary housing for 40 orphans.

However, like so many times Divine Providence intervened in the form of the Seeds of Compassion Movement. The true beauty of this movement is it only requires us to share our innate compassion for vulnerable children and endangered animals by adding our name (doesn't have to be our real name) and energy to the map by donating just \$1. Post August 16th

Dear friends, picking up the timeline again in the mid-1970's, in my last post of this period (August 6th) I related that the "Silent Majority" in America, being parents became increasingly concerned with the hedonistic culture's influence of the 1970s on their children. As I reported, this concern had begun much earlier in the UK, culminating in the Nationwide Festival of Light.

Nonetheless, it is strange how events occurring in our life when we are young, can literally go over our head. When I was researching the reaction of the "Silent Majority" to the out-of-control hedonism, I was surprised how many names I recognized. As a teenager, I can remember hearing the name Mary Whitehouse nearly every night on the news, complaining about one thing or another, most often TV programs. At that age I saw her as an "old fuddy-duddy", a name I and my friends

used for “old people” determined to stop anyone having fun. However, I do not remember the nationwide Festival of Lights or the movement behind it. It seems that it began in November 1970 when a “Peter and Janet Hill, returned to England after four years as evangelical Christian missionaries in India.” Shocked at what he perceived was an out of control “permissive society”, Peter Hill began gathering like-minded people together, to share “his concern.” Following the support from several denominations, the group conceived of publicizing the “problem” with a nationwide festival. Although the Festival “stimulated inter-denominational contact among evangelical Christians” historians note its “impact was minimal.” It was simply a matter of money, therefore, the “commercial, political and artistic pressures worked against any attempt at a stricter censorship, either by law or by voluntary agreement.”

Since Mary Whitehouse was denouncing one program or another for being immoral every other day, consequently, I was not that surprised to learn that in 1971, the parents of the Baby Boomers in the UK were concerned. Nonetheless, I was surprised to learn that by the mid-1970s American Hippie Baby Boomers had begun to shift towards evangelical Christianity. According to the *70s Fever* Documentary, by 1976 America was moving towards conservatism, with as many as 40% of the population claiming to be born again. To understand why a generation born to transform the world would in essence reverse their philosophy of non-traditionalism, we need to understand the term born again. According to the late Reverent Billy Graham:

*A born-again Christian is someone who has repented of their sins and turned to Christ for their salvation, and as a result has become part of God's family forever. ...You see, by nature we aren't members of God's family, and we don't have any right to inherit eternal life. The reason is because of our sin. We have rebelled against God, and because of that, the Bible says, we are “separated from the life of God ... due to the hardening of (our) hearts” (Ephesians 4:18). ...But Jesus Christ came to save us and to make us part of His family forever! He did this by dying for our sins on the cross and by conquering death through His resurrection. You see, as a human being you were born into a family—and nothing can ever change that. But when we come to Christ, we are spiritually reborn into another family—the family of God...*

We find the origin of the term “born again” in John 3:3, which has, “Jesus replied, ‘Very truly I tell you, no one can see the kingdom of God without being born again’.” The term “born again” gained new popularity in the 1970s through Watergate conspirator Charles Colson’s “very publicized conversion-to-Christianity”, and the equally public declaration of being a “Born-Again Christian” by the U.S. Presidential candidate Jimmy Carter.

In the first half of the 1970's decade, many Baby Boomers were lost in drugs and sex. Worse still, large numbers had even gone so far as to join religious sects, giving up their free-will to gurus. From the spiritual perspective, the entire generation was in danger of forgetting their purpose for incarnating, exactly as the "*Shadow*" intended. Consequently, the "*Light*" working with the spiritual aspect of the mass consciousness decided to "reset" large numbers of them. This action was needed to help the Baby Boomers rear the next generation to take up the reins where their parents had left off. Mary Whitehouse CBE – 1910 - 2001

According to her entry on Wikipedia Mary Whitehouse was born on June 13th, 1910, in Nuneaton, Warwickshire. "She won a scholarship to Chester City Grammar School... and after leaving she

did two years of unpaid apprentice teaching at St John's School in Chester, Cheshire. At the Cheshire County Teacher Training College in Crewe... she was involved with the Student Christian Movement before qualifying in 1932. She became an art teacher at Lichfield Road School in Wednesfield, where she stayed for eight years, and at Brewood Grammar School, both in Staffordshire.

Evidently, Mary Whitehouse “became a public figure via the Clean-Up TV pressure group, established in 1964, in which she was the most prominent figure. The following year she founded the National Viewers' and Listeners' Association, using it as a platform to criticize the BBC for what she perceived as a lack of accountability and excessive use of bad language and portrayals of sex and violence in its programs. During the 1970s she broadened her activities and was a leading figure in the Nationwide Festival of Light, a Christian campaign that gained mass support for a period. She initiated a successful private prosecution against Gay News on the grounds of blasphemous libel, the first such case for more than 50 years. Another private prosecution was against the director of the play *The Romans in Britain*, which had been performed at the National Theatre...

“Whitehouse's campaigns continue to divide opinion. Her critics have accused her of being a highly censorious, bigoted figure, and her traditional moral convictions brought her into direct conflict with advocates of the sexual revolution, feminism, children's rights, and LGBT rights. Others see her more positively and believe she was attempting to halt a decline in Britain's moral standards...”

Post August 17th

Dear friends, in this final “upstepping” in *Root-race 7*, we see the emergence of the last or 7th *sub-race*/level in the human realm. Not surprisingly, it culminates in the energetic return of The Universal Christ, and so, the seventeen years it incorporates have particular value to the treatise’ premise. Consequently, I have once again divided this section into three parts. (A) partially focuses on the temporary retardation of the Baby Boomer generation, requiring a “resetting” of their consciousness. Still, its primary focus is on the conscious and spiritual effects of the discovery of the planetoid Chiron, especially the planetoid’s connection to *Great Spirit-mind’s* plan for America. Then (B) follows the investigation on the development of America, delving more deeply into the energy and consciousness development. It also recaps many of the key points from previous sections. Finally, (C) encapsulates the “*Shadow’s*” domination, which began in the 1980s and lasted for 3 decades, as well as discussing how both sides prepared for The Universal Christ’s energetic return.

Starting with part A, I ended the previous “upstepping” with the election of President Jimmy Carter, who we know today as a promoter of peace and justice. Considering

the theme of this treatise though, I was a little surprised to learn that he was a born-again Christian, because I discovered that he was also a significant representative of the "*Light*." Examining the turbulent years accompanying his term in office, we will see how those four years affected the consciousness so much that America would never be the same again.

However, the effects in the consciousness coinciding with President Carter's term did not become evident until the 1980s. Even so, determining the energetic and consciousness ramifications requires us to examine the events of the late 1970s from the historical standpoint, which begins with the presidency of Jimmy Carter, running from 1976 to 1980.

According to his entry on Wikipedia, initially the Governor of Georgia Jimmy Carter's candidacy was not taken seriously by many Americans. Before the "presidential primaries in 1976, he was considered to have little chance against nationally better-known politicians..." Nonetheless, as the writer of the entry points out, the country was still bitter over the Watergate Scandal, not to mention the subsequent resignation and pardon of Richard Nixon. As a result, Americans were ready for an "outsider"; i.e., someone not part of the political structure of Washington DC. Carter's candidacy was further strengthened by his pledge of "government reorganization." Irrespective of his distance from the corruption seen in Washington, Governor Carter was not initially the frontrunner, demonstrated in the Gallup poll taken on January 26th that stated: "Carter was the first choice of only four percent of Democratic voters." The entry explains that according to the author Laurence Shroup, "by mid-March 1976 Carter was not only far ahead of the active contenders for the Democratic presidential nomination, he also led President Ford."

As history attests, on Election night November of 1976, Governor Carter narrowly defeated the incumbent President Gerald Ford. From the outset, President Carter's back was up against the wall, so to speak. Demonstrated by the fact in 1977, the United States was gripped in the energy crisis brought about by the OPEC countries punishing America for its support of Israel during the Yom Kippur War. So severe was the crisis that the new president attempted to rally the country into implementing energy conservation. Attempting to be an example, Carter "installed solar panels" on the White House roof and "wore sweaters while turning down the heat." The entry also relates some of the hi-lights of his administration:

- His tenure was a time of continuing inflation and recession, as well as an energy crisis...

- He canceled military pay raises during a time of high inflation and government deficits.
- He declared amnesty to Vietnam draft dodgers.
- While attempting to calm various conflicts around the World, most visibly in the Middle East resulting in the signing of the Camp David Accords, giving back the Panama Canal and signing the SALT II nuclear arms reduction treaty with the USSR, the final year of his administration was marred by the Iran hostage crisis...

Although President Carter's time in office was not considered a success in America, I wanted to review his presidency as objectively as possible. Therefore, as with previous presidents, I turned to the historians of History.com to provide a balanced overview:

*As president, Carter sought to portray himself as a man of the people, dressing informally and adopting a folksy speaking style. He introduced a number of ambitious programs for social and economic reform and included a relatively large number of women and minorities in his cabinet. Despite Democratic majorities in the House and Senate, Congress blocked Carter's proposal for welfare reform, as well as his proposal for a long-range energy program, a central focus of his administration. This difficult relationship with Congress meant that Carter was unable to convert his plans into legislation, despite his initial popularity...*

*In 1977, Carter brokered two U.S. treaties with Panama; the following year, he presided over a tough round of meetings between Egypt's President Anwar el-Sadat and Israel's Prime Minister Menachem Begin at Camp David. The resulting Camp David Accords ended the state of war between the two nations that had existed since Israel was founded in 1948. Carter also reopened diplomatic relations between the United States and China while breaking ties with Taiwan and signed a bilateral strategic arms limitation treaty (SALT II) with the Soviet leader Leonid Brezhnev.*

*Throughout his presidency, Carter struggled to combat the nation's economic woes, including high unemployment, rising inflation and the effects of an energy crisis that began in the early 1970s. Though he claimed an increase of 8 million jobs and a reduction in the budget deficit by the end of his term, many business leaders as well as the public blamed Carter for the nation's continuing struggles, saying he didn't have a coherent or effective policy to address them. In July 1979, Carter called a special summit with national leaders at Camp David. His televised speech after the meeting diagnosed a "crisis of confidence" occurring in the country, a mood that he later referred to as a "national malaise."*

*In November 1979, a mob of Iranian students stormed the U.S. embassy in Tehran and took its diplomatic staff hostage as a protest against the arrival in the United States of the deposed Iranian shah, Mohammad Reza Shah Pahlavi, in order to receive medical treatment. The students had the support of Iran's revolutionary government, led by Ayatollah Ruhollah Khomeini. Carter stood firm in the tense standoff that followed, but his failure to free the hostages led his government to*

*be perceived as inept and inefficient; this perception increased after the failure of a secret U.S. military mission in April 1980. ...He was defeated by a large margin in the general election that year by Ronald Reagan, a former actor and governor of California who argued during his campaign that the problem facing the country was not a lack of public confidence, but a need for new leadership*

In 1979, I was living in the UK where it was generally believed that Carter's downfall was caused by the situation in Tehran. Nevertheless, I realize that as President Carter favored *Great Spirit-Mind's* plan for America, the "Shadow" needed him removed. Foregoing the discussion on the cause for Carter's downfall until later, I need to acknowledge his great accomplishment in presiding over a historic moment on the international front. Obviously, this was the Peace treaty he brokered between Israel and Egypt. This inspiring moment was immortalized by the photograph taken at the Camp David Accords, showing Israeli Prime minister Menachem Begin shaking hands with Egyptian President Anwar El Sadat, with the smiling President Carter overseeing the scene. Although President Sadat acknowledged Israel by travelling to Jerusalem and speaking at the Knesset (Israel's Government Building), it was the first time an Arab nation publicly recognized Israel as a nation on foreign soil. Despite this auspicious beginning, much of the agreement was never implemented, as since that time Israel has maintained an uneasy truce with its Egyptian neighbor. ## Post August 19th

Dear friends, what the excerpt from President Carter's entry did not relate was that tragically elsewhere in the world, during his administration, a conflict occurred that would lead to the horror known as the Killing Fields. This Cambodian genocide by the Khmer Rouge was clearly instigated by the "Shadow", yet before examining how "he" convinced human beings to butcher their fellow countrymen and women, let us review the official historical record of the background behind it. I found the best examination of it by Adam Taylor of the Washington Post. His article is succinct and to the point, as is seen in the excerpts below:

*The Khmer Rouge's name, and that of its main leader, Pol Pot, have become a short-hand for systematic cruelty and horror on an enormous scale. The reality is almost certainly impossible to imagine for people who were not there. Between 1975 and 1979, 1.7 million Cambodians are believed to have lost their lives. For a such a small country, that created an effect that lasts to this day: Almost one in five people living in Cambodia at the time is believed to have died as a result of Cambodian genocide.*

*Radicalized during a time of anti-imperialism and Communist ideology, Pol Pot (born Saloth Sar) and many other founders of the Khmer Rouge (officially the Communist Party of Kampuchea) were well-educated students who had lived in France yet felt alienated by post-independence Kingdom of Cambodia. In 1968, they formed the Khmer Rouge as an offshoot from the Vietnam People's Army from North Vietnam. ...many historians now believe that a U.S. bombing campaign in their country drove many rural Cambodians into the arms of the radical ideology. On April 17, 1975, two years after the U.S. pulled out of Vietnam, Phnom Penh fell to Khmer Rouge troops and U.S.-supported government forces surrendered.*

*Just days after the Khmer Rouge took power, they ordered 2 million people living in Phnom Penh and other urban areas to head to the countryside. This was to be "Year Zero" in Cambodia's new rural, classless society, and the country would now be known as the Democratic Kampuchea. The idea was based on an extreme version of Maoism and a belief in the superiority of the Khmer people, the predominant ethnic group in Cambodia. Citizens were to be turned into traditional rural peasants, referred to as the "old people" by the Khmer Rouge. Urban workers and intelligentsia elites were viewed as "new people" and easily expendable. Survivors remember being told that the revolution would be successful without them: "To keep you is no benefit, to destroy you is no loss."*

*The move to the countryside was only factor in the changes. According to the Cambodian Tribunal Web site, "money, free markets, normal schooling, private property, foreign clothing styles, religious practices, and traditional Khmer culture" were all abolished. People were confined to their cooperative farms and forced to wear traditional black outfits. Hundreds of thousands of soldiers, intellectuals, and minorities were imprisoned or killed. Of the 14,000 who entered one prison, a former high school renamed S-21, only seven were believed to have survived. As anti-Vietnamese paranoia set in, even Khmer Rouge loyalists found themselves executed.*

In my research, I had learned that the Cambodians were facing starvation in 1975, which made me wonder how America reacted to the crisis. In 1975 Gerald Ford was president, so I needed to go to his entry on Wikipedia to find the answer. However, the only reference to Cambodia I could find on Gerald Ford's entry was a brief reference to an incident involving the Khmer Rouge's seizure of an American merchant ship in the late spring of 1975. The incident occurred just after the televised fall of Saigon. At this time, the Khmer Rouge had taken control of Cambodia. On the day in question, "Cambodians seized the American merchant ship *Mayaguez* in international waters." President Ford responded by ordering "Marines to rescue the crew, but the Marines landed on the wrong island and met unexpectedly stiff resistance just as, unknown to the U.S., the *Mayaguez* sailors were being released." During the course of the rescue, "two military transport helicopters carrying the Marines" were "shot down", resulting in the deaths of 41 Marines and a further fifty wounded, with "approximately 60 Khmer Rouge soldiers" losing their lives.

Sadly, my answer as to what the West did for the Cambodian famine of 1975, was essentially nothing. True, no one could have conceived that anyone would perpetrate such a barbaric action as the Killing Fields. Even so, I suspect that the "*Shadow*" distracted any caring person in the West from the plight of the Cambodians with the Oil crisis.

Now we come to how the "*Shadow*" was able to instigate such an atrocity; basically "he" used fear to nullify the morals of Western leaders. While in Cambodia, "he" used an equally dangerous mental attitude, "righteous" indignation, stemming from the injustice between the people. We have seen this tactic of the "*Shadow*" used multiple times throughout history, such as the French and Russian revolutions. In these revolutions, the "*Shadow*" stirred up the discontent of the peasant laborers already present, to blame the wealthy and privileged for their predicament, putting a face to their rage and resentment. This is what essentially happened in Cambodia.

The educated Cambodians lived a more comfortable life in the cities than those living in the countryside. Due to this inequality, the "*Shadow*" was able to recruit "his" representative Pol Pot, which like Manson and other "representatives" had freely chosen to accept the "*Shadow's*" urgings. A remarkable fact about this genocide is that it was directed at educated members of society. I say remarkable, because as Adam Taylor noted, Pol Pot and his cohorts, were "well-educated students." Inflaming the sense of injustice in his citizens, Pol Pot turned it into the more spiritually destructive emotions of envy and jealousy, which then boiled into rage and hatred, enabling normal rational human beings to carry out the most

inhumane acts. “Pol Pot’s” task was made easier by the “*Shadow*” using the energy from the Japanese occupation and their inhuman acts of torture, as these acts released the consciousness of hate and brutality, the fuel for genocide.

The most devastating aspect of the Killing Fields was that Pol Pot used children as his executioners. I say it was the most devastating aspect, because these children have had to live with the guilt of their actions. Although I doubt that Pol Pot was aware of it, as the children were below the age of spiritual responsibility their human egos and counterfeit-spirits had greater control of them. With this knowledge, it is essential that these former children are taught that they were victims of a power-hungry megalomaniac and that they bear absolutely no responsibility for their actions. The real tragedy is that this genocide could have been averted, if the West had only responded to the report of the Cambodian famine with a massive airlift of food and assistance. However, in May 1975, the Khmer Rouge became the enemy of America by seizing the *Mayaguez*. Consequently, President Ford, with the help of the “*Shadow’s*” prodding through the president’s counterfeit-spirit/pain-body, was not predisposed to help the Cambodian people.

The reason I have covered this tragic episode so extensively is because from a consciousness and energetic perspective, the genocide was devastating. Not just because of the loss of life, but because Pol Pot used children of the Baby Boomer generation born to transform the world. This genocide, like the corruption of the Hippies, would temporarily have disastrous consequences to the “*Light’s*” objective for the world. I will explain how a little later, but first, while the genocide was taking place in Cambodia, back in America an event took place that shook the population to its very core. Pol Pot 1925 - 1998

According to his entry on Wikipedia, Pol Pot was born on May 19th, 1925, to a prosperous farmer in French Cambodia. Educated at some of Cambodia's most elite schools, Pol Pot arrived in Paris in October 1949 on an academic scholarship. Later, he joined the French Communist Party in 1951. "Returning to Cambodia in 1953, he involved himself in the Khmer Viet Minh organization and its guerrilla war against King Norodom Sihanouk's newly independent government. Following the Khmer Viet Minh's 1954 retreat into North Vietnam, Pol Pot returned to Phnom Penh, working as a teacher while remaining a central member of Cambodia's Marxist-Leninist movement. In 1959, he helped formalize the movement into the Kampuchean Labour Party, which was later renamed the Communist Party of Kampuchea (CPK). To avoid state repression, in 1962 he relocated to a jungle encampment and in 1963 became the CPK's leader. In 1968, he relaunched the war against Sihanouk's government. After Lon Nol ousted Sihanouk in a 1970 coup, Pol Pot's forces sided with the deposed leader against the new government, which was bolstered by the United States military. Aided by the Viet Cong militia and North Vietnamese troops, Pol Pot's Khmer Rouge forces advanced and controlled all of Cambodia by 1975."

"Pol Pot transformed Cambodia into a one-party state that he called Democratic Kampuchea. Seeking to create an agrarian socialist society that he believed would evolve into a communist society, Pol Pot's government forcibly relocated the urban population to the countryside and forced it to work on collective farms. Pursuing complete egalitarianism, money was abolished, and all citizens were forced to wear the same black clothing. Mass killings of perceived government opponents, coupled with malnutrition and poor medical care, killed between 1.5 and 2 million people, approximately a quarter of Cambodia's population, a process which was later termed the Cambodian genocide."

“Repeated purges of the CPK generated growing discontent; by 1978 Cambodian soldiers were mounting a rebellion in the east. After several years of border clashes, the newly unified Vietnam invaded Cambodia in December 1978, toppling Pol Pot and installing a rival government in 1979. The Khmer Rouge retreated to the jungles near the Thai border, from where they continued to fight. In declining health, Pol Pot stepped back from many of his roles in the movement. In 1998, the Khmer Rouge commander Ta Mok placed Pol Pot under house arrest and shortly afterward, Pol Pot died.”

## **August 20<sup>th</sup> – Extra post on why I use the cards in the Major Arcana of the Tarot**

Dear friends, before I continue with my recap of the time between Globes, I want to explain the reason for using the Major Arcana of the Tarot. As I have said, in the Treatise the Tarot cards represent archetypes of divinity, as well as different levels of consciousness. However, without knowing the path I was led on to reach my understanding of the Tarot holding the Ancient Mysteries, I realize that I have no credibility. Therefore, because I believe the cards are so much more than a means to foretell the future, I will share that story at this time.

Since this is a very long story, I will break it into several posts. This first post is from the Minor Arcana's "Dedication" I wrote for my Anthology of the Tarot *BEYOND DIVINATION: Minor Arcana's Role in Spiritual Transformation, and BEYOND DIVINATION: Spiritual Transformation through the Major Arcana*. I use the Minor Arcana's volume because it was the first volume I wrote in the Anthology, and because it lays out the basic premise of the Anthology.

### **DEDICATION & ACKNOWLEDGMENTS**

I dedicate this work to all those who have contributed to our knowledge of the Tarot, by either creating decks or investigating what the cards mean. In joining the hundreds of investigators who have studied the mysterious Tarot and shared their understanding, I acknowledge that I am standing on the shoulders of some of the world's greatest inspired scholars. As I am neither a Tarot reader nor a scholar, my contribution may appear out of place. However, I was called to this work by a series of events and encounters, which I will explain shortly.

My examination of the Tarot began in 1999, but its roots are much older, as it started when Arthur Edward Waite commissioned Pamela Colman Smith to create 78 images, to represent the 22 Major, and 56 Minor Arcana cards in the Tarot deck. These images had openly existed in one form or another for over five hundred years,

but there are many who speculate that they may be a lot older. Foregoing this supposition for the time being, most historians concur that the first appearance of the 4 suits of the Minor Arcana in the West occurred in Italy during the 1300s. Still the most famous Italian decks are the *Visconti-Sforza*, *Sola-Busca*, and *Boiardo-Viti* decks of the late 1400s. Initially, there were very few copies of these decks as they were all hand-painted, but once Johannes Guttenberg invented the Printing Press, the decks could be mass produced outside of Italy. One of these decks, the *Marseilles-Milan* deck, who some credit to the Catholic priest *Marsilio Ficino*, inspired the Rider-Waite deck, so my first dedication goes to the artists and printers of these first Tarot decks.

In 1910 A. E. Waite commissioned Pamela Colman Smith to create the Rider-Smith-Waite deck; nonetheless, Waite did not stop with creating the famous deck; he wrote extensively on what the cards meant. Providing a glimpse into the mysteries of the cards, he wrote *The Pictorial Key to the Tarot*, which was illustrated to accompany his Tarot deck. Yet he went further the same year his deck was released, writing the *HIDDEN CHURCH OF THE HOLY GRAIL ITS LEGENDS AND SYMBOLISM*, which connected the Minor Arcana to the legend of the Holy Grail. As a result, my next dedication goes to Arthur Edward Waite and Pamela Colman Smith, for their inspired effort to enlighten the world on the Mysteries in the Tarot.

Since the Rider-Smith-Waite Tarot has been in print, multiple Tarot enthusiasts have dedicated their lives to uncovering the hidden meaning in the card's images. One of the earliest was an anonymous Rabbi, who after working on the images for several years, handed the task over to an equally anonymous Jesuit priest, who was so affected by the work that he left his order, and dedicated his life to studying the Tarot images for the next forty years. In the 1970s, the now ex-Jesuit priest met Daphna Moore, and the two developed a close friendship. After a while, he, who Daphna simply called E.S.C., handed both his and the Rabbi's work over to her, with the instructions that after adding an explanation of the symbolism, she ensures that their work was published. Their collective work eventually manifested as the published book *The Rabbi's Tarot*. When it was no longer in print, my husband Craig and I stepped in to preserve these valuable teachings, in *Ancient Teachings on the Ego: in Daphna Moore's RABBI'S TAROT*. Therefore, my next dedication goes to the anonymous Rabbi, the ex-Jesuit priest E.S.C., and Daphna Moore, which I collectively designate as the Daphna group, for giving so much of their selves to the benefit of Humanity.

Over the years, as I said, multiple people have studied the Tarot endeavoring to uncover its secrets. In my treatise *AMERICA'S HIJACKED DESTINY...on Spiritual*

Evolution with a focus on the United States' role, I connect these investigations to a collection of enigmatic individuals whose mission in life was to uncover *The Mysteries*. I identify the investigators as inspired members of the "Orders of the Quest", most of whom were/are completely unaware of their predestined role. In this roster of dedicated individuals, who helped me to understand the deeper mysteries of the Tarot, I include (alphabetically), Jonathan Dee and his *TAROT MYSTERIES: Rediscovering the Real Meaning of the Cards* and Johannes Fiebig & Evelin Bürger's *THE ULTIMATE GUIDE TO THE RIDER WAITE TAROT*, written appropriately for Llewellyn Publications. I say appropriately because it was Llewellyn's version of *The Rabbi's Tarot* that initiated my investigation. Marcus Katz and Tali Goodwin's book, *SECRETS OF THE WAITE-SMITH TAROT: The True Story of The World's Most Popular Tarot* also focuses on Mr. Waite and Pamela's deck. Last but by no means least is Benebell Wen and her book *HOLISTIC TAROT: An Integrative Approach to Using Tarot for Personal Growth*, which provides a comprehensive study of the Rider-Smith-Waite deck. Then there was the amazing vision of Dion Fortune and her *MYSTICAL QABALAH*, which demonstrates the deeper levels in the Tree of Life. My husband Craig and I read this amazing book while we were studying *The Rabbi's Tarot*. However, it was not until I was collating all the information for my treatise on Spiritual Evolution that I remembered, how Dion Fortune connected the Kabbalistic teachings to the Tarot's Minor Arcana. Therefore, I would like to acknowledge Ms. Dion's contribution to our knowledge, by including her in this dedication.

Demonstrating my process in interpreting the Tarot, I also include excerpts from the chronological aspect of my aforementioned treatise on America's role in Spiritual Evolution, which was 24 years in the making and published in the Spring of 2018. This endeavor includes material from my previous books inspired by multiple authors who helped with my understanding. Two perfect examples are Dr. Carl Johan Calleman, and his book *The Nine Waves of Creation: Quantum Physics, Holographic Evolution, and the Destiny of Humanity*, and Michael Poynder's *The Lost Magic of Christianity, Celtic Essene Connections*. Since there are far too many authors, who contributed information to my treatise to include them all in this dedication, I will acknowledge their books as, and when I mention them.

Along with the above authors, I want to acknowledge Éliphas Lévi's contribution, as he was a clear influence on A.E. Waite's deck. In that influence I must include Dr. Papus and his book, *ABSOLUTE KEY TO OCCULT SCIENCE IN THE BOHEMIAN TAROT*, and A.E. Thierens' book *GENERAL BOOK OF THE TAROT*, both of which were graciously provided by Aisha from Global Grey Books for a small donation. Finally, Tarot would not be fully understood without the science of

Numerology, so I also want to dedicate my work to W. Wynn Westcott and his book *Numbers: Their Occult Power and Mystic Virtues*. Other writers who contributed to my understanding, include Paul Foster Case, Aleister Crowley, Lon Milo DuQuette, Dr. Yolanda Robinson, and Manly P. Hall. Obviously, there are many more anonymous investigators of the Tarot who have gone unrecognized, and in conclusion I want to acknowledge and dedicate this work to them too.

(Note: Although this book is inspired by multiple sources and authors, I have chosen to write it in my own words, acknowledging the source wherever appropriate. It is my sincere wish that I convey these brilliant authors contribution, who I see as members of the “*Orders of the Quest*” in helping to bring *The Mysteries* to Light.)



Post August 20th

Dear friends, recapping what the documentary *70s Fever* (introduced in the previous section) reported on religious sects, there were 300 “fringe religious groups” in San Francisco alone. One of the groups in the city was the *People’s Temple* run by Jim Jones, involving a great many Baby Boomers. As the events’ surrounding Jim Jones was a pivotal moment in the corruption of the consciousness, it is essential to examine how the situation arose. What is really interesting is that the story of Jim Jones is a lesson of how a good person, who genuinely wants to help people, can become so twisted that they end up harming them. Excerpts from the entry on Wikipedia for Jim Jones provides the background and development of what appeared to be the noble enterprise of Jones Town. Apparently, he started his ministry in 1952 as a “student pastor in Somerset Southside Methodist Church.” When its leaders “barred him from integrating blacks into his congregation”, he left the Church. It was “around this time” that he experiences a “faith-healing service at the Seventh Day Baptist Church.” Noticing that it drew both “people and their money”, he reasoned that if he could heal too, the money raised would enable him

to implement “his social goals,” consequently, Jones established his “own church”, which eventually became the People’s Temple Christian Church Full Gospel.

Jim Jones must have been doing something right in his community, because “in 1960, Indianapolis Democratic Mayor Charles Boswell appointed Jones as a director of the Human Rights Commission.” Unfortunately, this is when we begin to see Jones’ ego raising its head, as he began seeking an audience through “local radio and television programs.” Even so, Jones “also helped to integrate churches, restaurants, the telephone company, the police department, a theater, an amusement park, and the Methodist Hospital.” When someone painted swastikas on two African American families’ houses, Jones responded by walking around “the neighborhood comforting African Americans and counseling white families not to move.” A year after his appointment, he was inadvertently “placed in the black ward of a hospital after a collapse in 1961.” After the staff apologized and tried to move him, Jones insisted he stay in the black ward, “and began to make the beds, and empty the bed pans, of black patients.” His action led to political pressure, which “caused hospital officials to desegregate the wards.”

On the personal note, Jones and his wife Marceline “adopted several children of at least partial non-Caucasian ancestry”, which he designated “as his ‘rainbow family,’ and stated: ‘Integration is a more personal thing with me now. It’s a question of my son’s future.’ That comported with Jones’ portrayal of the Temple overall as a ‘rainbow family’...”

By all accounts, Jones was a socialist, which he promulgated in the late 1960s in his sermons. He called his version “Apostolic Socialism.” Jones described it as “those who remained drugged with the opiate of religion had to be brought to enlightenment -- socialism.” However, according to his entry, Jones would “often” merge “concepts, such as preaching that ‘If you’re born in capitalist America, racist America, fascist America, then you’re born in sin. But if you’re born in socialism, you’re not born in sin.’” In 1970, he switched to attacking traditional Christianity as the problem, calling it a “fly away religion.” He also rejected “the Bible as being white men’s’ justification to subordinate women and subjugate people of color.” Moreover, Jones believed its content “spoke of a ‘Sky God’ who was no God at all.”

Recognizing that his ministry was stagnating in Indianapolis, in 1975 Jones moved the Peoples Temple headquarters to San Francisco. It proved to be beneficial, because it “invigorated Jones’ political career. After the Temple served an important role in the mayoral election victory of George Moscone in 1975, Moscone appointed Jones as the Chairman of the San Francisco Housing Authority Commission.”

Much of the above account of Jim Jones actions can be deemed laudable and in keeping with the "*Light's*" objective. Yet the entry also mentions that he claimed to be the reincarnation of among others, Jesus and The Buddha, revealing that his corruption began in the early 1970s. Something that always surprises me is how often Socialism is associated with the Communism of the former USSR and China, but as I said earlier they are like chalk and cheese.

Unfortunately, when Jim Jones became corrupted by the "*Shadow*", he exhibited the traits of modern communism, "authoritarian, repressive and coercive." Initially Jones was advocating and demonstrating the socialistic views of unity, equality and compassion, so, the question is how did a man dedicated to equality and bringing heaven to earth become so twisted? His entry relates incidents that may help reveal the answer. Evidently, he was arrested in 1973 for solicitation, when he approached a male undercover "vice officer" in a "movie theater bathroom known for homosexual activity, in MacArthur Park in Los Angeles." This event would appear to reveal Jones as a hypocrite because he preached that he was "the only true heterosexual." Nonetheless, the author of his entry reports that there is "at least one account" reporting "his sexual abuse of a male member of his congregation in front of the followers, ostensibly to prove the man's own homosexual tendencies."

In addition, although Jones prohibited carnal relations between his followers unless they were married, he "voraciously engaged in sexual relations with both male and female Temple members." Jones explained this as him "engaging in homosexual activity", which he abhorred, in order to "symbolically" link the "male temple adherents" to their leader. In other words, it was for their "own good." This account would seem to confirm that Jim Jones decline began in the early 1970s when the People's Temple was operating in Redwood Valley California.

We find a clue as to how Jim Jones went from a social leader, who was an example of humility (emptying bed pans of patients), to a megalomaniac that thought moral behavior did not apply to him, in the identity of one of his inspirations, Father Divine.

To be honest I was unfamiliar with Father Divine, so I looked him up on Wikipedia and found an entry that succinctly sums up this mysterious figure, as originally George Baker Jr., an African American, born in the 19th century. He became a "spiritual leader" around 1907 reinventing himself into the Reverend Major Jealous Divine. According to the entry, Father Divine was also called "the Messenger." Sounding a lot like someone inspired by the "*Light*", "He founded the International

Peace Mission movement, formulated its doctrine, and oversaw its growth from a small and predominantly black congregation into a multiracial and international church.” However, as “Father Divine claimed to be God”, I knew that he was not a member of the “*Orders of the Quest*”, but I do not view him as an agent of the “*Shadow*” either, because he “made numerous contributions toward his followers’ economic independence and racial equality.” Rather I see him as someone who became misguided by his false ego, which I suspect is what happened to Jim Jones. Both Jim Jones’ downward spiral into megalomania and “Father Divine’s” assertion that he was “God”, is evidence of how dangerous it is for spiritual people to have followers. This is especially true when you combine it with a sense of genuine “righteous anger” at the injustice the individual sees. The temptation to want to save people, rather than just “sharing” the knowledge of how they can save themselves, is sometimes intoxicating, which is why Jesus consistently demonstrated humility and asserted that it was the meek (humble) that would inherit the earth.

Without an understanding of the ego and counterfeit spirit/pain-body continually trying to undermine spiritual progress, many spiritual leaders fall under the spell of believing they are worthy of worship when their followers (congregation) pay homage to them. I know firsthand how it can feel when someone you are sharing information with “light’s up” with understanding. Interestingly, it is not the counterfeit-spirit/pain-body that is the problem here, although the “*Shadow*” is still involved, it is the conscious part of the false self, the human ego. The key to circumvent the false self and “*Shadow*” here, is for the “sharer” to know that what he or she is experiencing is the person’s spirit that is literally leaping for joy at the prospect of finding a kindred spirit. Moreover, it is important to always keep in mind that all knowledge is available to anyone who “has ears to hear and eyes to see.”

Whenever an individual reacts to knowledge with understanding, it is essential that the “sharer” tells them exactly where and how they obtained it and direct them to it for further study. If these precautions are not taken, then the individual is in danger of allowing the ego and “*Shadow*” to use this feeling to make the person “sharing” feel special. I believe that this is what happened to Jim Jones. He was genuinely loved by his congregation who came to hang-on his every word. Yet instead of empowering the congregation, Jones’s ego gradually convinced him that he was worthy of worship. From there it was a simple thing for the “*Shadow*” working through Jones’ counterfeit-spirit to subliminally suggest that he was “God” and therefore no earthly rules applied to him. When Jones became to all intents and purposes “king” of the Agricultural Project in Guyana, his corruption was complete. Consequently, when his “kingdom” was threatened from outside, as he believed that death was not the end, he acted to keep it intact in another world.

Even so, the impact that the mass suicide would have on the Baby Boomers was far more important. I will address the affects later, but first let us review the shocking event from Jones page on *Encyclopedia Britannica*. After the press began accusing Jones of misappropriating the finances of his members, from reports of ex-members, in 1977 he decided to take the People's Temple to Guyana, to establish a self-contained agricultural compound called Jonestown.

When family members worried about their loved ones in Guyana approached Congressman Leo Ryan about their concern, he agreed to mount an investigation into Jonestown. Contacting Jim Jones, Ryan arranged for an official visit to the compound in Guyana to investigate the accusations of abuse. Their visit was arranged for November 14th, 1978, and when they arrived, Jones appeared completely compliant with Ryan's investigation, maintaining that anyone who wanted to leave was free to do so; that is until they tried to leave. As the page relates, on November 18th when Ryan and the members who wanted to leave left the compound, Jones sent a team to assassinate them all. However, as the team only succeeded in killing Ryan, three reporters, and one other, there were survivors who managed to escape. Therefore, fearing that the survivors:

*...might bring in authorities, Jones activated his suicide plan... he commanded his followers to drink cyanide-adulterated punch, an order that the vast majority of them passively and inexplicably obeyed. Jones himself died of a gunshot wound in the head, possibly self-inflicted. Guyanese troops reached Jonestown the next day, and the death toll of cultists was eventually placed at 913 (including 276 children).*

The vision of the bodies lying on top of each other was almost beyond comprehension for many Americans and caused a ripple of fear of any and all fringe religious groups. As a result, the public viewed all Christian or any other religions that were not mainstream, as cults. Naturally, as this was in the consciousness of the generation born to transform the world, the energy generated affected the world, manifesting itself in a panic in the late 1980s of satanic cults carrying out rituals on their children. Alas, it was not just the mass suicide at Jonestown that caused the panic but the consequences of the corruption of the Baby Boomers, which began in the mid-1970s. The documentary *70s Fever* provides us with many facts that help explain what happened in the 1980s. Since it mentions several points that show the shift in the mass consciousness of the Baby Boomers, but before I discuss them, I feel that I need to explain what I mean by mass consciousness here. ### **August 21st – Extra post on why I use the cards in the Major Arcana of the Tarot**

Dear friends, in the summer of 1999, Elizabeth, who we had recently met handed me *The Rabbi's Tarot* by Daphna Moore, stating “You need to read this book because it was vital to your work.” At that time, I understood the Tarot as a tool for divining the future and wondered why Elizabeth would want us to read a book on fortune telling. However, within the first few pages, it was clear Elizabeth was not exaggerating when she said it would be vital to our work, because the book was unmistakably about transformation.

Through the early years of the millennium we re-read *The Rabbi's Tarot* several times, each time gaining something else from it. Eventually we wrote to Daphna telling her how much we valued her work, and we were delighted when she graciously replied. We mentioned how we came to actively collaborate with her for more than ten years, in the book *FOR THE CHILDREN* that we wrote for our friend Dr. Carol Sue Rosin. The purpose for the book was to raise money for her Treaty banning Space-based weapons, and children's charities by telling her story. Insisting

that we include Craig's and my story too, I decided to write it from the perspective of how the ego entwines itself throughout life, while recounting our life stories.

Upon first writing to Daphna commending her for *The Rabbi's Tarot*, we found her very open and unpretentious, taking her role in producing the book in stride. Exchanging phone numbers, we discussed how best to present this incredible information. At first, Daphna offered to sign over the copyright for the book to Craig and me. Although, this showed her magnanimous nature in considering that she did not own the material, we felt she should keep the copyright.

We wondered at the reason for Daphna's inspiration in offering to sign over *The Rabbi's Tarot* to us. It did not make sense until 2006, when I had several visions. These visions connected the 22 Major Arcana cards of the Tarot to the Tree of Life and the esoteric teachings on Globes and Root-Races. This in turn led to me writing parts one and two of *Spiritual Evolution: From the Fool to the Hermit* recorded on our website.

My visions became even more relevant, when I had the revelation that Daphna carries the consciousness of Helena Blavatsky (The founder of the Theosophical Society and author of *The Secret Doctrine*). By this, we mean that the consciousness in Blavatsky is one of the accumulated life-consciousness in Daphna. As the consciousness divides into masculine and feminine when we die, several people can carry aspects of the consciousness of any given life. In fact, this is where the concept of "soul mate" comes in.

After publishing the visions' interpretations (*Spiritual Evolution: From the Fool to the Hermit*) on the web, we thought our role in *The Rabbi's Tarot* was over. Then Daphna reworked *The Rabbi's Tarot* in 2009 and asked if she could use our letter for one of the endorsements on the back cover. Following its publication, she told me she wanted to create a Glossary and Index for it. As I felt it would help in studying, I offered to do it for her. This created a much deeper collaboration between us, resulting in Daphna becoming an associate of the I.D.E.A. Foundation and assisting me with her expertise in astrology and numerology. When Daphna told us she was running out of the paperback versions and was unable to run another print, we offered to create an E-book including the Glossary and Index to sell on our site, making the precious material from the book available, but it was always a stopgap. We all knew the need for a physical version of the book.

In the Spring of 2014, I felt inspired to use my mother's money to reprint *The Rabbi's Tarot*. As I expected, my husband agreed it was a perfect way to honor her passing. In discussing how to proceed, we knew we needed to use a more descriptive title for the book. So meditating/praying about it, we felt inspired to use *Ancient Teachings on the EGO in Daphna Moore's Rabbi's Tarot* for the title. Then Craig suggested including the information from *Spiritual Evolution: From the Fool to the Hermit* from the *Ancient Wisdom For Now* page on our website. We had both wondered about the visions connecting the 22 cards and the Tree of Life, not to mention the Globes and Root-Races.

In the original *Rabbi's Tarot*, at the end of each card Daphna had a blank page for notes. We felt these pages could easily accommodate an additional commentary to each card. It seemed a perfect way to add to the book, without compromising its integrity. Moved to put the copyright for the book in our Foundation's name, we wanted to share the royalties with Daphna. Therefore, half would go to the Foundation and half to her. To us, it was important to honor Daphna's contribution.

With our plan laid out, it was time to ask Daphna how she felt about our idea for reprinting *The Rabbi's Tarot* with an additional commentary. Planning to call her later that morning, I went to my computer. Routinely checking Skype, I saw there was a message from Carol, who was home from hospital. To my surprise, Carol wrote of how my mother's spirit visited her the last night she was in intensive care. She related, "your mother came to me and told me to tell you 'everything is good, be happy'."

Amazingly, we later determined that my inspiration to use my mother's money for *The Rabbi's Tarot* occurred on the same night she "visited" Carol. My mother's message to Carol was her way of letting me know, she understood what we were doing. In other words, she inspired me to use her money for the book. All Carol wrote when I told her was "WOW!!!!" That said it all. Later, calling Daphna we were delighted when she enthusiastically agreed. What was more, she was quite happy for us to use the new title. Like us, Daphna thought that it would reveal the importance of the contents to humanity. Knowing that my mother was not only aware of what I was doing, but was now supporting it, was such a gift.

Over the years, Daphna shared her role in this amazing material. We knew from her foreword that Arthur E Waite and Pamela Coleman Smith produced the Rider-Waite Tarot Deck in 1910, and that shortly after, a member of the *Orders of the Quest*, a group of individuals working for the *Light*, recognized the importance of the images and symbols in the 22 Major Arcana cards. Namely, they were concealing the process of transformation. As a Rabbi, he was well versed in the Kabbalistic teachings; consequently, he worked on interpreting the messages in the 22 cards for several years. After going as far as he could, moved to find someone else to continue the work, the Rabbi handed his work over to another member of the *Orders of the Quest*. Surprisingly, this member was not another Rabbi. Instead, he was an ex-Jesuit priest. Accepting the responsibility, the former priest worked on the material for a further 40 years.

In the 1970s, Daphna Moore attended one of the ex-Jesuit's lectures. After the lecture, she spoke with the former priest. Experiencing a strong rapport between them, Daphna immediately formed a bond and began a relationship with him. Part of their relationship consisted of the member of the *Orders of the Quest* teaching his acolyte what he knew and subsequently in this respect he became her mentor. Over their years together, Daphna learned of his work with the Tarot. Then one day the ex-Jesuit handed her a box full of papers: the collected contribution of the Rabbi and his 40 years work on the 22 Major Arcana of the Tarot. Telling his protégé that she needed to add her contribution, he instructed her to interpret the symbols in the cards. Before she left him to begin her monumental task, Daphna's mentor asked her to combine all three contributor's material into a manuscript and get it published.

Daphna later related that it took her several hard years' work to complete the symbolism of the 22 cards. However, fulfilling the second part of her mentor's wish was even harder. At first, she could not find a publisher, which forced her to self-publish the manuscript. To achieve this required Daphna selling her cherished metaphysical book collection to finance its publication. She named the book *The Rabbi's Tarot* in honor of the man who first inspired its creation. Subsequent to Daphna's publication of the book in the early nineties, *Llewellyn Publishers* picked up the book and published a new edition in 1995. It was this version that Elizabeth gave us in 1999.

What we did not know at the time was that I would recolor the 22 Major Arcana cards of the Rider-Waite Tarot deck, to conform with the Symbology in *The Rabbi's Tarot*. Using a program I had never used before, Craig and I were surprised how quickly I finished the task, but then again, I was following my spiritual guidance all the way. My primary focus, apart from ensuring the color matched *The Rabbi's Tarot*, was to create archetypes of the figures in the cards, in order to be able to separate them from the background. As with so many times in my journey, I was not clear as to the reason why.

I guess I should not have been surprised when Craig suggested I recolor the remaining 56 cards of the Minor Arcana, thereby creating a complete deck. Again, I made sure that all the figures in the cards could be separated from the background. I finished the newly colored deck, which we were calling the *R-S-W Arcana's Tarot* January 2016.

The amazing thing is that the inspiration to recolor the cards did not stop with my commentary on *The Rabbi's Tarot*, because afterwards I was moved to create an anthology on all 76 cards of the Tarot' representing *The Mysteries* teachings on Spiritual Transformation. However, I included multiple tarot aficionados' analyses, including Eliphas Levi, and Paul Foster Case in compiling my interpretation. It was from a desire to raise the level of the Tarot from a fortunetelling tool that we entitled the 2-volume anthology, *BEYOND DIVINATION: Minor Arcana's role in Spiritual Transformation*, and *BEYOND DIVINATION: Spiritual Transformation through the Major Arcana*.

As I promised in response to Graciela's comment on my post, for anyone, who like me cannot speak or read Spanish, I used Google translate for providing her insightful deeper meaning of card 17 The Star:

“The archetypes of innovations are formed precisely with the interpretation of the symbols:

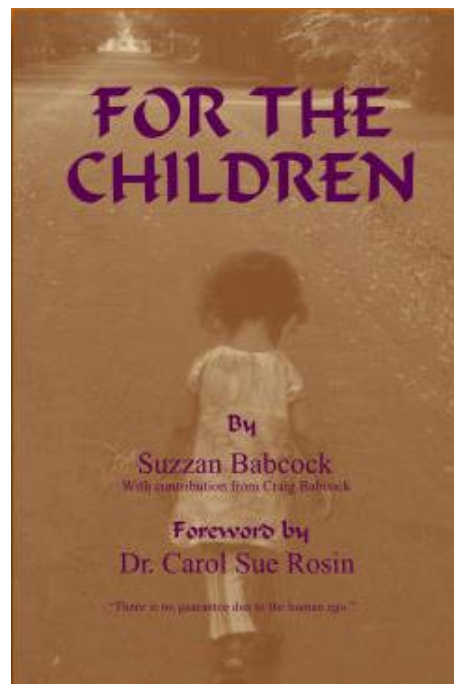
The sounds that create both the interior and the exterior, the ↓ and the above, have to do with "in the beginning was the word, and the word was God...

Dear friends, Craig related to me that until recently he thought the term mass consciousness referred to awareness rather than a linking of minds. The concept that the world's consciousness was somehow connected was first brought to light by Carl Jung, who coined the term "collective unconscious." He believed that the unconscious connection explained why two people on different continents could spontaneously invent the same thing at the same time, with absolutely no communication or collaboration.

I should state that the above description held true until 1945, manifesting in the cultural advancement of the nations. Nonetheless, after the veil was ripped by the Hiroshima and Nagasaki bombings, everything changed. With the Divine Realm determining that the souls incarnating from August 1945 would have a mission to transform the world, the mass consciousness became individualized, but also connected. To understand what I mean, I need to use the Archetypes in the Major Arcana of the Tarot, which brings me back to Craig's comment about the term "mass consciousness." He thinks that the RT's term "Mind-Stuff" in *The RABBI'S TAROT* more accurately describes the unconscious mental connection between living organisms.

In the Major Arcana of the Tarot, there are two cards representing the subconscious, card 2 – The High Priestess and card 3 – The Empress. Carl Jung's "collective unconscious" is represented by the High Priestess, which is also the Mind-Stuff referred to by the *RT group*. However, the unconscious, or rather sub-conscious connection of the Baby Boomer generation is represented by The Empress. This is an important distinction, because The Empress represents the Individual Sub-conscious, formed from the union of the Universal or Cosmic Sub-conscious (High Priestess) and the Self-conscious (Magician). Consequently, this was a level of connection that was far more aware, which means that Craig's original interpretation of the term "mass consciousness", was closer to the definition than would appear.

Although the *RT group's* term Mind-Stuff applies to the Universal or Cosmic Subconscious, because it provides a visual explanation and can be applied to an actual "network" operating in the world, I will use it in reference to the Baby Boomer's connection. At this time, the network I am referring to is the Internet, or the web of information linked through computers. An important thing to remember is that the information connects through satellites and miles of cable, as a result, at any given moment there are literally quadrillions of packets of information travelling through the air, so to speak. It is because of this fact that the data mining system

Web Bot can sift through the information to accurately predict future events. What Web Bot uses is in effect the “Mind-Stuff” of the world’s consciousness. Consequently, to understand how individuals can affect and be affected by the collective thoughts of others, all we need to do is replace computers with human brains, meaning that the individual human brain acts as a Web Bot taking in the packets of information, sifting, decoding and then processing it.

Sadly today, much of the data transmitted are negative thoughts and actions. Fortunately, the vibrations of love, joy, and compassion produce the strongest vibrations and can counteract the negative. This is why such a small percentage of the population (777,000) can create a critical mass to shift the world’s Mind-Stuff. Even so, connecting the subconscious of billions of individuals is a double-edged sword. We see a perfect example of this reported in the documentary *70s Fever*, concerning the spread in the sightings of UFOs. David Cassidy relates that in the summer of 1973 there was a wave of over a thousand UFO sightings that amazingly rose to 15 million in less than six months.

The above information helps us understand what happened to the Baby Boomers and how the dream of peace and justice for all seemed lost after the 1970s. As I said, there were several points mentioned in the documentary *70s Fever* that shows the shift in the mass consciousness (Mind-Stuff) of the Baby Boomers. In July of 1977 there was a blackout in New York in which 500 police officers were injured and 4,500 looters arrested. David Cassidy compares this number to a blackout which occurred in 1965, when only 5 people were arrested for looting. Another example was the popularity of jogging and the jogging suit, when the “suit” became a status symbol for the jogger to demonstrate his or her desire to take care of their health. Cassidy compares the 15,000 participants in the New York Marathon of 1979 to the 150 entrants in 1970.

For me, the documentary *70s Fever’s* most disturbing information was the observation that the number of murders doubled during the ’70s from the number during the 1960s. As the majority of the murderers in the 1970s were members of the generation born to transform the world, I found this information staggering. Many people attribute the rise in violence to the increase in drug use and of course this was a factor. Still, something told me there was an underlying energetic cause that was affecting the Baby Boomers and making them more prone to violence. 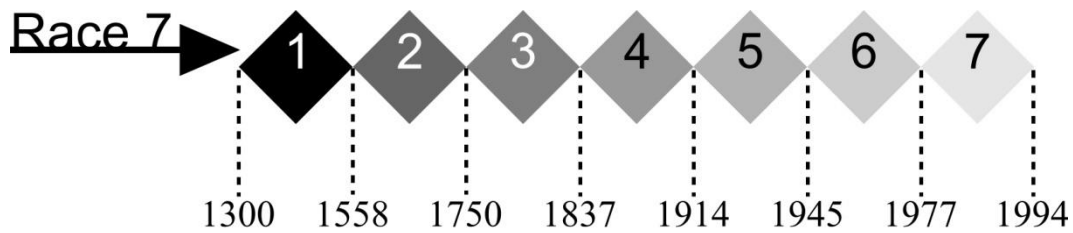

Dear friends, to reiterate, the “*Shadow*” used the actions of the Japanese to incite the genocide in Cambodia between 1975 and 1979, temporarily devastating the “*Light’s*” objectives, because Pol Pot used children as his executioners. Tragically, apart from the corruption of the Cambodian Baby Boomers, I learned there was another more insidious reason why the “*Shadow*” focused on Cambodia, namely, the Buddha’s Plan B. Cambodia’s energetic consciousness predominantly came from the majority of its people being Theravada Buddhists, who adhered closely to Gautama Buddha’s teachings. One of the primary teachings is to respect all life, as in they never take sentient life. Buddhists believe that all animals are sentient and are therefore strict vegans. The Buddha’s Plan B used Theravada Buddhist monks to transmute the world’s lower emotions, which meant they were connected to the mass consciousness of the planet.

Pol Pot’s use of innocent children (children of the Baby Boomers generation) to butcher between 1 and 3 million people, caused a ripple effect of violence to be sent through the Mind-Stuff or mass consciousness. Those of weaker wills would be the most affected by the vibration. Even so, because free will is sacrosanct, individuals affected who chose to act on the impulse were still guilty of murder.

The reason so many Baby Boomers around the world succumbed to the lower vibrational behavior, was because their choices and actions had already lowered their vibrations. To explain what I mean by lower vibrations, I refer to the graph at the start of every section throughout this treatise. The graphs show the primary level of consciousness in each section’s “upstepping”, I repeat this section’s time-line for *Root-race 7* below:



**Diagram of the 7th Root Race and dates of the sub-races**

Examining the diagram, we can observe that the Baby Boomer generation emerged under the 6th *sub-race* of *Root-race 7*, meaning that every baby born between 1945 and 1976 were of that vibration. As with all previous sections or “upsteppings”, immediately after birth the vibrational level of the individual becomes subject to their environment/mass consciousness. Moreover, as the child grows and develops consciously, his or her cumulative choices gradually affect whether he or she lowers or raises their vibration level, before they reach the age of spiritual decision (21). For example, the Cambodian children taking part in the genocide greatly lowered their vibration.

In the mid-1960s, the vibrational level for most of the Baby Boomers was in the 6th *sub-race* of *Root-race 7* and was on target for rising to the next and highest level in the next decade. However, because of events during the latter half of the '60s decade, the “*Shadow*” manipulated a large percentage of Baby Boomers into lowering their vibration, exacerbated by their choices. This continued into the 1970s and the level of consciousness began decreasing exponentially, so much so that by the mid-1970s more than half of the generation had lowered their vibration several levels. Since there were so many individuals that incarnated to fulfill *Great Spirit-Mind's* plan, their deterioration literally brought down the mass consciousness (Mind-Stuff) of Humanity and violent and or licentious behavior began spreading throughout the world.

As I wrote the above, I was struck by the apparent failure of the generation of hope, but I realized that only *Great Spirit-Mind* knew the plan. Then again, “He/She” was playing the long game and therefore, what appeared to be failure could be used by the “*Light*” to His/Her advantage. I always needed to keep in mind that a human being on *Globe D's* job is to transmute the emotions and thereby spiritualize matter. I know this may seem daunting and to many obscure, but I think it may help to consider how there are five stages to the emotion of grief. I found an excellent summation in excerpts from Elizabeth Kubler Ross's description of the 5 stages on an entry in Wikipedia, reproduced below:

- **1 - Denial** — "I feel fine."; "This can't be happening, not to me."
- **2 - Anger** — "Why me? It's not fair!"; "How can this happen to me?"; "Who is to blame?"
- **3 - Bargaining** — "Just let me live to see my children graduate."; "I'll do anything for a few more years."; "I will give my life savings if..."
- **4 - Depression** — "I'm so sad, why bother with anything?"; "I'm going to die . . . What's the point?"; "I miss my loved one, why go on?"
- **5 - Acceptance** — "It's going to be okay."; "I can't fight it, I may as well prepare for it."

Regarding the five stages above, they are referring to an individual's own impending death, as in a person facing a terminal illness, but the five stages can equally be applied to the grief of losing a loved one. *THE GOOD NEWS REVERBERATION* relates that the ancient teachers believed grief was the source of evil, because it could lead a person to the much lower emotion of hatred. This is especially true in the case of another individual causing the death of a loved-one. The goal is to pass through the five stages without becoming consumed by anger or depression, to eventually find acceptance. In the case of the death being caused by another individual, it is essential that the person grieving finds forgiveness for the perpetrators as well as acceptance of their loved one's death. A sign that he or she has transmuted the grief, occurs when in thinking of the deceased, there is no longer pain, anger, or resentment, all that remains are fond memories. When all the bereaved feels are fond memories and warm feelings about their loved one being at peace, his or her vibration is raised, consequently, experiencing emotional pain can actually lead to spiritual advancement. Next we will examine another factor that sabotaged the spiritual advancement of the Baby-boomer generation, the so-called sexual revolution, but again I must reiterate that this has nothing to do with any kind of moral judgment of any kind, just an objective examination of how the "Shadow" tricked and manipulated young and often naïve people into thinking that they were fulfilling their destiny by bucking society's system. Post August 23rd

Dear friends, before I get to today's post, I need to emphasize that I examined the subject of this and the next post from the spiritual evolution perspective. Consequently, in discussing the spiritual ramifications of the so-called sexual revolution during the 1970s, we must always remember that this has nothing to do with morality or any kind-of judgment. Here, the purpose is to objectively look at the situation and its consequences in connection with the resetting of the consciousness in the late 1970s

Considering that the Baby Boomer generation was born to transform the world, investigating this period puzzled me because of the behavior of many members of the generation. Above I discussed how people became more violent in this "upstepping", but in light of the events of the '60s and '70s and the "*Shadow's*" machinations, it was somewhat understandable how a peace-loving generation turned to violent activism. Still, after learning of the sex clubs of this era, I was at a

lost to how enlightened individuals could regress to almost animalistic pleasure seeking. I questioned how so many individuals who chose to be born to transform the world could become so hedonistic. The answer as always starts and ends with freewill. Nonetheless, at the energetic or consciousness level, this is another example of the Individual Subconscious of the Baby Boomers being connected. If we return to the 1960s for a moment, we will see how the Hippie movement's slogan to "Make Love, Not War" could be translated in several ways, one being the concept of "free love", meaning individuals in communes demonstrated their love for one another by engaging in sexual intercourse.

Multiple times I have stressed that the spiritual term of *Hieros Gamos* (Sacred marriage) was often wrongly interpreted to mean physical sex, instead of a reference to uniting the masculine or active and feminine or passive aspects in the individual. Two of the main culprits to this misunderstanding was the misinterpretation of the Hindu *Kama Sutra* and the corruption of the teachings of a type of Buddhism known as Tantric. I think it may help if we briefly review these two systems, but on the subject of Tantric sex, we will also look at the modern version of it known as Neotantra. Examining the entry on Wikipedia for the *Kama Sutra*, we find that there are "seven parts" to it. Each part is attributed to different authors, which is explained by Vātsyāyana, who relates that his contribution was "an abridgment of longer works by Dattaka (first part), Suvarnanabha (second part), Ghotakamukha (third part), Gonardiya (fourth part), Gonikaputra (fifth part), Charayana (sixth part), and Kuchumara (seventh part)." The entry reports that "Vātsyāyana's *Kama Sutra* has 1250 verses, distributed in 36 chapters", which are then, "according to both the Burton and Doniger translations... structured into seven parts."

In respect to our discussion, the second part was the only clear description that matched what I had heard of the *Kama Sutra*. This is because it contains, "ten chapters on various aspects of sex, which I won't repeat here. However, it "describes 64 types of sexual acts." Not surprisingly, the first part is a "general" introduction to the "contents." Three parts concern various comments on marriage, as in "Acquiring a wife" and the so-called, "duties and privileges of the wife." It also discusses, "other men's wives", and courtesans. There is also advice "on the choice of lovers, looking for a steady lover, ways of making money, renewing friendship with a former lover, occasional profits, profits and losses."

Determining the energy behind the *Kama Sutra*, I found it pretty straightforward as the focus is on the material world, which is the exact opposite to the objective of Spiritual Evolution. However, the corruption of The Buddha's teaching is evident with another statement in the entry that says the *Kama Sutra* "warns against the

dangers that come with the search for pleasures of the senses.” This statement appears under the passage, “Some Indian philosophies follow the ‘four main goals of life’, known as the *purusharthas*:

- Dharma: Virtuous living.
- Artha: Material prosperity.
- Kama: Aesthetic and erotic pleasure.
- Moksha: Liberation...

Apparently, the supreme objective is virtue followed closely by a safe and “secure life”, and seeking pleasure is a distant third. The *Kama Sutra* advice that when any of the three objectives conflict with one another, then the “highest ideal” must be the objective. In this way, financial undertakings would never “compromise” a person’s virtue and “earning a living should take precedence over pleasure.” Even so, the entry qualifies this with “there are exceptions.” Such as when young. Vātsyāyana explains that as a young adult a person “should learn how to make a living”, but that it is also a “time for pleasure.” As we age, we need to “concentrate on living virtuously”, in order to avoid “the cycle of rebirth.” Ultimately, the *Kama Sutra* warns us of our “senses”, in that they “can be dangerous.” Quoting from part 2, chapter 7, verse 33, which uses an analogy, it relates “Just as a horse in full gallop, blinded by the energy of his own speed, pays no attention to any post or hole or ditch on the path, so two lovers, blinded by passion, in the friction of sexual battle, are caught up in their fierce energy and pay no attention to danger.”

Initially, I was surprised to learn that the Buddha “preached a *Kama Sutra*, which is located in the Atthakavagga (sutra number 1).” Nevertheless, according to the author, the Buddha’s version “is of a very different nature as it warns against the dangers that come with the search for pleasures of the senses. Many in the Western world wrongly consider the *Kama Sutra* to be a manual for *tantric sex*. While sexual practices do exist within the very wide tradition of Hindu Tantra, the *Kama Sutra* is not a Tantric text, and does not touch upon any of the sexual rites associated with some forms of Tantric practice.”

Interestingly, the final part of the *Kama Sutra* concerning “Occult practices”, has two chapters on improving physical attractions and arousing a weakened sexual power. I mentioned in *Volume I* how Tantric Buddhism involves raising the Kundalini, yet through investigating the seeming contradictions, I discovered that Tantric Buddhism is also a deeply esoteric and advanced form of Buddhism, which is restricted to only the most disciplined initiates. It became corrupted in its neo-form during the 1960s, but first let us review its traditional use:

*Tantra techniques in Vajrayana Buddhism are techniques used to attain Buddhahood. Vajrayana partially relies on various tantric techniques rooted in scriptures such as tantras and various tantric commentaries and treatises. The most important aspect of the tantric path is to 'use the result as the Path'; which means that rather than placing full enlightenment as a goal far away in the future, one identifies with the indivisible three Vajras that is, the enlightened body, speech and mind of a Buddha. The practitioner focuses on and identifies with the resultant Buddha-form or 'meditation deity', the yidam (Tibetan) or (Sanskrit) 'ishtadevata'. In order to achieve this self-identification with the yidam, much symbolism, ritual and visualization is used in Buddhist tantric techniques. Tantra is defined as an inner realization that functions to prevent ordinary appearances and conceptions and to accomplish the four complete purities of a Buddha (environment, body, enjoyments and deeds)."*

*Secrecy is a cornerstone of tantric Buddhism, simply to avoid harming oneself and others by practicing without proper guidance. It is not even allowed to explain the full symbolism and psychology of the practice to the uninitiated, which can easily lead to misunderstanding and dismissal by the uninitiated. Tantric techniques may initially appear to consist of ritualistic nonsense; however, it should only be practiced on the basis of a thorough understanding of Buddhist philosophy and strictly following the traditions.*

*Tenzin Gyatso, the 14th Dalai Lama says: Tantra is limited to persons whose compassion is so great that they cannot bear to spend unnecessary time in attaining Buddhahood, as they want to be a supreme source of help and happiness for others quickly.*

Turning to the modern evolution of Tantrism or Neotantra, this form of Tantrism has become associated with sacred sexuality. Still, before I investigate this development in Buddhism, I feel I need to address the meaning of raising the sex-force to the mental level. Earlier, I identified the "sex-force" or more correctly, the "Life-force/Principle" with the Christ-consciousness, however, it is important for me to clearly state that raising the sex-force, also known as *Hieros Gamos*, equates to awakening and activating this divine consciousness within us. It is one thing to know that we need to raise the sex-force to the mental level to transform and quite another to describe how it is done. The wonderful thing is that there are no special ceremonies involved, it simply happens as a result of the individual changing the way they think. I thought long and hard on how I could best describe exactly what I mean by raising the sex-force. In meditating/praying on the problem, I was reminded of the thrill or "goose-bumps" I get whenever I made a breakthrough in understanding. Then I understood that the "high" or shiver up the spine is the sex-force raising or rather the Christ-consciousness awakening. When a person hears the Truth, and realizes the spirit within them, the feeling is their connecting to *Great Spirit-Mind*. Now to examine the raising of the Kundalini otherwise known as Neotantra. I found the most succinct explanation on the web site SRIBD, which in brief describes it as:

*...the modern, western variation of tantra often associated with new religious movements. This includes both New Age and modern Western interpretations of traditional Hindu and Buddhist tantra. Some of its proponents refer to ancient and traditional texts and principles, and many others use tantra as a catch-all phrase for “sacred sexuality” and may incorporate un-orthodox practices. In addition, not all of the elements of Indian tantric practices are used in Neotantra, in particular the reliance on a guru. As the interest in Tantra has grown in the West, its perception deviates remarkably from the Tantric traditions. It was seen as a “cult of ecstasy”, combining sexuality and spirituality to correct Western repressive attitudes towards sex. Hence for many modern readers Tantra is now synonymous with “spiritual sex” or “sacred sexuality,” a belief that sex should be recognized as a sacred act capable of elevating its participants to a higher spiritual plane.*

Regardless of the modernization of this ancient practice, essentially at the highest-level Tantrism involves “raising Kundalini energy, worshiping the divine feminine, and activating the chakras.” The entry for Neo-tantra includes “experiencing full-body orgasms” but I believe like corrupting the *Hieros Gamos*, some teachers focused on teaching it as a “set of techniques for cultivating a more fulfilling sexual or love relationship.”

From the above, it was clear to me that both the *Kama Sutra* and Neo-Tantrism connected actual physical intercourse with spiritual enlightenment. This would have appealed to the Baby Boomer generation, as their mission was to raise their consciousness and become enlightened. Nonetheless, it is important to remember that Gautama Buddha warned of focusing on the physical senses as it misdirects the focus. If we remember that in the late 1960s, the Beatles joined an Indian Guru for a time, we can see how these teachings could spread. Although all four were ultimately disillusioned, the band’s initial involvement initiated an interest in America of mystical religious practices. Alas, as destructive as Neotantric sexual rituals were to Spiritual Evolution, unfortunately, a far more dangerous aspect of sexuality was revived in the 1960s and 1970s, pornography. Dear friends, before I continue I need to clarify that when I said, all concerned with pornography were degraded, and it affected the spiritual progression of the world, I was speaking energetically. If we consider that the purpose of Life is to spiritually evolve by raising our vibration, whenever an individual focuses on the physical senses, they lower their vibration. Unfortunately, in the case of pornography, it affects the mass consciousness.

According to the entry for pornography on Wikipedia, pornography has existed in some form or other throughout human history. An excerpt from the entry explains the term pornography as “the depiction of sexual subject matter for the purposes of sexual arousal.” Evidently, the term Pornography stems from the Greek word (*pornographia*), originating from the Greek words “*pornē*, ‘prostitute’ and *pornea*, ‘prostitution’, and *graphō*, ‘I write or record’,” which means “illustration” or “graph.” Graphō with the “suffix - *ia*, meaning ‘state of,’ ‘property of,’ or ‘place of’, changes the meaning to “a written description or illustration of prostitutes or prostitution.”

The first sentence of the entry sums up the purpose and reveals the danger of pornography, namely, to use visual images of sex acts to cause “sexual arousal.” Explaining that the concept of pornography as understood today did not exist until the Victorian era, the entry relates that when the remains of Pompeii were discovered

during the mid-19th century, people were shocked by the Roman erotic art that was unearthed. Because the Victorians considered themselves “the intellectual heirs of the Roman Empire”, they immediately removed all “moveable objects” to a “Secret Museum in Naples.” Anything that could not be removed, was “covered and cordoned off as to not corrupt the sensibilities of women, children and the working class.” The author connects the shocking discovery with “the world’s first law criminalizing pornography”, which was passed as part of “the Obscene Publications Act” of 1857.

Photographs of the female form have been around since the invention of photography. During WWII, “pinup” photographs of famous actresses saw many GIs through the hardship of battle. “Girlie” magazines, featuring nude photos started in 1953 with Hugh Hefner’s first edition of his *Playboy* magazine, which featured a nude picture of Marilyn Monroe. *Playboy* was joined by another publication in 1965 when Bob Guccione launched his *Penthouse* magazine. These two magazines were known as “soft porn” and were seen as harmless by most Americans. However, in November 1974 Larry Flynt published the first edition of what is known as “hard-core porn” in his *Hustler* magazine. I am not going to discuss the details of Flynt’s publications, suffice to say that although he was not a Baby Boomer, because he was born in 1942, he was used by the “*Shadow*” to corrupt them.

After bucking the establishment with his explicit displays of women’s private parts, which made him a millionaire, Flynt became a born-again Christian. He credited his change from “a vision” he had when he was flying “his jet.” Believing the “vision” was from *Great Spirit-Mind*, Flynt apparently continued publishing his magazine as a promise “to hustle for God.” Regardless, at some point, “God” must have disappointed him because according to his entry, “He has since declared himself an atheist.” Flynt first faced prosecution over his magazine in 1976, when he was charged with “obscenity and organized crime” in Cincinnati. Although, Flynt was found guilty and given a sentence of 7 to 25 years, he only “served six days”, because the conviction “was overturned on a technicality.”

Many of his critics thought justice caught up with Larry Flynt when, fighting another charge of obscenity two years later in Gwinnett County, Georgia, while walking to the courthouse with his attorney, Flynt was shot. The author of his entry explains the outcome. It seems that the “shooting left Flynt partially paralyzed with permanent spinal cord damage, and in need of a wheelchair. Flynt’s injuries caused him constant, excruciating pain and he was addicted to painkillers until multiple surgeries deadened the affected nerves. He also suffered a stroke caused by one of several overdoses of his analgesic medications. He recovered but has had pronunciation

difficulties since.” Interestingly, the assailant was not motivated by outrage at the sexual images, apparently, it was “White supremacist serial killer Joseph Paul Franklin”, who later confessed, he was “outraged by an interracial photo” within *Hustler* magazine.

Unfortunately, pornography on Larry Flynt’s scale results in collective Lust, and because the Mind-Stuff or mass consciousness is connected everyone is affected by its energy. As I said, the Baby Boomer generation was unique in that their individual sub-consciousness’ were connected through the Internet, still their most important connection is in having the same soul imperative, to “Know Thyself” and transform. Therefore, the problem of pornography, especially the “hard-core” type, was not because large numbers of the Baby Boomer generation indulged in pornography, it was because it stimulated an aspect of their consciousness, which changed the world’s consciousness. Pornography is spiritually harmful because each individual consciousness also incorporates Creative Imagination, which means the power to literally create reality.

The above statement might appear a little out there but consider how material things are created. Let us take a beautiful statue like Michelangelo’s *David*, it began with a vision in the sculpture’s head (Creative Imagination), then he visualized the statue in the block of marble and carved away until his vision became a reality. This procedure is repeated in every single creation in our reality. A high-rise building begins as an idea in the architect’s head (his Creative Imagination), before he produces his “vision” in a drawing, which is then transformed into reality by a construction crew. If we accept that our reality is constructed in a similar manner, then we can see that our “visions” can take form in the real world. A perfect example of this concept is found in the film: *What the Bleep Do We Know?* Because it is based on the premise that the universe is constructed from thought-forms of the mass consciousness.

By the late 1970s, pornographic videos were available locally in small towns everywhere. With the advent of television and the film industry, pictures which left any visual images up to the individual’s imagination became animated. This meant that everyone who watched these films saw the same thing.

Remembering that the purpose of pornography is to elicit sexual excitement, it is important to understand how it began to corrupt the Baby Boomers. Still, to explain this, I need to refer to our Tarot Anthology *BEYOND DIVINATION: Spiritual Transformation through the Major Arcana*, which reports the *RT group* explained that the Empress represents a combination of the individual and universal

subconscious. Consequently, the card symbolizes that “she” can either raise our vibration from spiritual thoughts or lower it from your desires. Moreover, it is important to remember that The Empress represents the planet and goddess Venus, denoting both love and desire. In this way, “she” can either inspire us to seek spiritual enlightenment or stimulate us to crave physical pleasure.



Due to the connection of the Mind-Stuff (mass consciousness) in the 1970s, the desire for “physical pleasure” was growing, as was seen in the sex clubs of the late ’70s. In the documentary *70s Fever*, David Cassidy informs us that between 1978 and 1979 conservatism grew exponentially. This movement began in 1977 when a former beauty queen Anita Bryant, launched a movement to ban homosexuality, claiming that Gays were child molesters. Even worse, she claimed that as homosexuality was a choice, children were in danger of being coerced into the lifestyle. Unfortunately, this movement was the tip of the iceberg in the drastic shift America was about to take. Shockingly this shift was a calculated decision of the “Light” in conjunction with the collective Mind-Stuff, or mass consciousness of the Baby Boomers. Shocking because its purpose was to stop the further deterioration of the “chosen” generation, by giving them space to raise their children in a relatively stable environment.

Let me share how I came to understand it. Since such large numbers of the Baby Boomers were involved in the counterculture of drugs and sex of the 1970s, their higher consciousnesses and the “Light” decided to temporarily “reset” them, to ensure that their children (generation-X), who were also part of the structure to transform the world, would have a stable environment in which to develop. Although the Soul enters under a certain energy vibration of the particular *sub-race* at the time of birth, as I said, from that moment on the progression or regression, in respect to vibration, is determined by the choices made by the individual, which is affected by the mass consciousness.

In the case of the Baby Boomer generation, because of the “*Shadow’s*” influence, as stated many of them began to seriously lower their vibration through their life choices, specifically, their attitude towards casual sex. Spiritually speaking, sexual intercourse without love is detrimental to the spiritual welfare of the individual, which is why the Bible warns against “fornication.” Again, this has nothing to do with any kind-of moral judgment. Post August 26th

Dear friends, just before the start of this final “upstepping” of the 7th *Root-race* most historians attribute Jimmy Carter’s election in 1976 to his declaration that he was “Born Again.” As I reported, when he was elected president in. 40% of America identified themselves as “Born Again Christians.” With hindsight, the moniker “born again” is associated to the Evangelical Movement that resulted as a backlash to the hedonism of the 1970s. What I did not realize until working on this treatise, is that this movement was subconsciously driven by the spirits within Baby Boomers, in order to rescue the generation from abject degradation. Again, as always, I am not speaking in moral judgment, but rather the spiritual and consciousness consequences of an individual’s actions. Even so, why did Baby Boomers choose, even if subliminally, to become born again to counteract the degradation? Obviously, spiritually they thought it would help, but how? Whenever I hear the term “born again”, I am immediately reminded of the passage in John 3: 1-12 where Jesus is discussing the subject with Nicodemus. Before I share my eventual understanding of the term, let us review the scripture. My *King James Study Bible* has:

*There was a man of the Pharisees, named Nicodemus, a ruler of the Jews: The same came to Jesus by night, and said to him, ‘Rabbi, we know that thou art a teacher come from God: for no man can do these miracles that thou doest except God be with him.’ Jesus answered and said unto him, ‘Verily, verily, I say unto thee, except a man be born again, he cannot see the kingdom of God.’ Nicodemus saith unto him, ‘How can a man be born when he is old? Can he enter the second time into his mother’s womb, and be born?’ Jesus answered, ‘Verily, verily, I say unto thee, except a man be born of water and of the Spirit, he cannot enter into the kingdom of God. That which is born of the flesh is flesh; and that which is born of Spirit is spirit. Marvel not that I said unto thee, ye must be born again. The wind bloweth where it listeth, and thou hearest the sound thereof, but canst not tell whence it cometh, and wither it goeth: so is every one that is born of the Spirit.’ Nicodemus answered and said unto him, ‘How can these things be?’ Jesus answered and said unto him, ‘Art thou a master of Israel, and knowest not these things? Verily, verily, I say unto thee. We speak that we do know and testify that we have seen; and ye receive not our witness. If I have told you earthly things, and ye believe not, how shall ye believe, if I tell you of heavenly things?’*

Many interpret the above passage as referring to Baptism, but Jesus could not have been referring to a person committing themselves to the Church, because when he made this statement the Church did not exist. So, what was he referring to? His statement of the difference between flesh and spirit obviously precludes physical birth. Then again, his next statement seems to be speaking of something tangible as

in the wind that can be heard and felt. The key to my understanding was Jesus' challenge to Nicodemus that the latter is "a master of Israel." This refers to Jesus' earlier condemnation of the Pharisees. Where he accused them of keeping the "key of knowledge" from the people (Luke 11:52), which clearly demonstrates that Jesus is referring to the Ancient Mysteries that used allegories to teach. Wind (Air) in *The Mysteries* refers to the mental plane, by saying that it is unknown, Jesus was saying that being born of water (Baptism) and the Spirit was a cleansing of the mind. Put another way, like a baby is born with a fresh mind, the individual needs to wipe their minds clear of all preconceived ideas.

Resetting the Baby-Boomers' consciousness was not without consequences. Souls that incarnated after 1945 had worked through multiple lives of religious conflict and were ready to reevaluate their beliefs. Unfortunately, the actions of the "*Shadow*" diverted large numbers of them from being ready for the final upstepping in 1977. Yet, in uncovering this information my logical mind asked how was it possible for the "*Shadow*" to succeed in derailing the "*Light's*" objective? Surely, the Divine Forces knew what was going on.

I learned that it concerns how time is perceived, because in the Astral Plane, and Soul Plane, linear time is a factor. Originally, I believed that there was "no time" in the Soul Plane, but I came to understand that "No Time" only applied to the higher or upper realms. Apparently, linear time is a construct of the Soul Plane to facilitate the transmutation of the elements, and as the "*Shadow*" was connected to the lower levels "he" operated linearly. Therefore, the only arena where "linear time" does not exist is in the Pleroma, which is why only *Great Spirit-Mind* knows everything that has happened, is happening, and will happen.

Since the resetting of the Baby-Boomers involved the Evangelical movement, which was Protestant, it required the consciousness of the generation to regress to the beginning of the Protestant Reformation. Alas, this resulted in regressing the mass consciousness at the subconscious level to 1514 when Martin Luther nailed the 33 theses on the door, which occurred during the 4th "upstepping" from 1300 to 1558. Obviously, the billion or so individuals involved did not go back in time, unfortunately what happened was much worse. 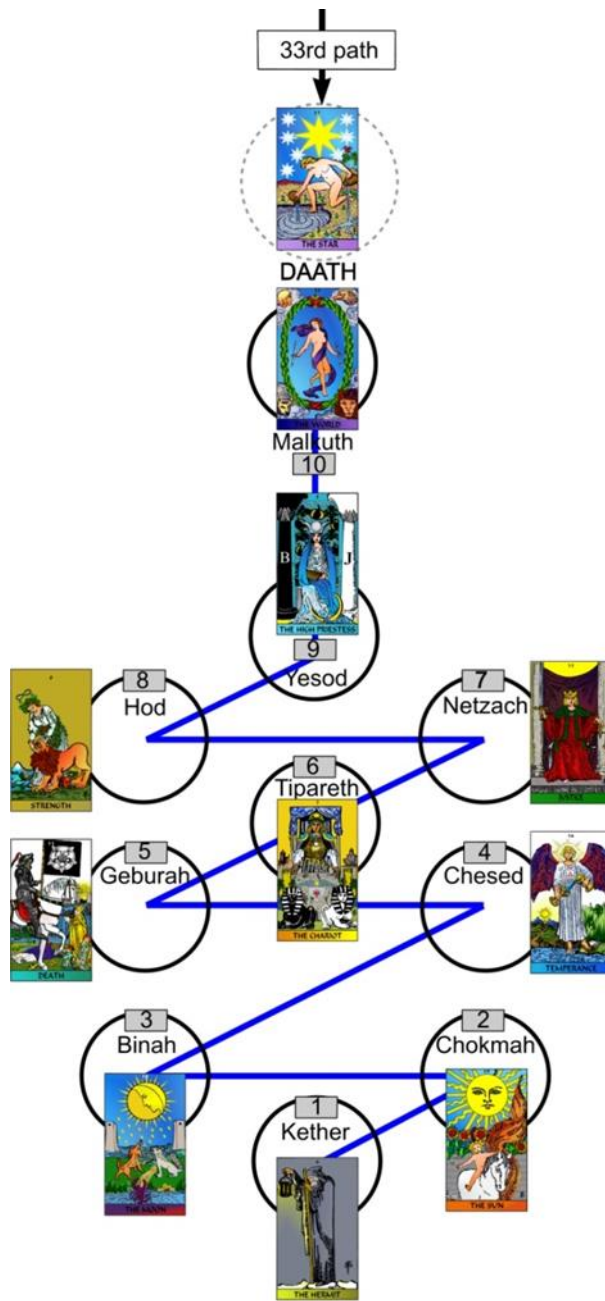


Post August 27th

Dear friends, on November 1st, 1977, a small planetoid was observed orbiting between Saturn and Uranus. Its discoverer named it Chiron and its appearance would have a profound effect on the Mind-Stuff or mass consciousness of the world. The change from the Angel of the Moon to the Angel of the Sun in 1881 brought the materialization of the Tree of Truth into the Astral Plane. Still, the tree's most important component did not interact with it until the discovery of its ruler's astrological Archetype manifested on the Physical Plane, Chiron.

As stated earlier, the pathway and door to the Tree of Truth was revealed with the emergence of the last *Root-race 7* in conjunction with the astrological alignment of 1524. Moreover, the start of the planetary rule of the Angel of the Moon in 1525 also marked *Root-race 7*'s emergence. Nonetheless, the Tree of Truth's materialization in the mass consciousness in 1881 was the turning point spiritually, but the real relevance of its materialization did not become apparent until this last "upstepping." With the discovery of Chiron, the Archetype of the Tree of Truth could begin operating as the beacon for the 777,000 individuals destined to transform the world. The tree hangs upside down, which means the top of the tree or *Kether* is situated at the bottom of the tree. This is to denote the same symbolic meaning as the downward

triangle in the six-pointed star, namely, spirit descending into matter. The Major Arcana card assigned to *Kether* in the Tree of Truth is card 9 - The Hermit.

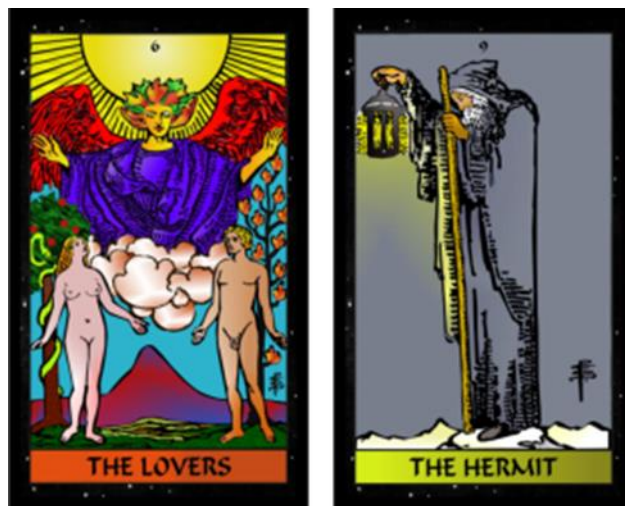


**THE TREE OF TRUTH**

Archetypally, The Hermit represents the Universal Christ at the macrocosmic or universal level, together with the Spirit or Divine spark within the individual on the microcosmic level. In other words, the discovery of Chiron represented the

interaction of the Universal Christ with Humanity. This was not the Second Coming, but the preparation for the first part.

Examining the figure in card 9 - The Hermit, we observe that he is holding up a lantern. Throughout this treatise we refer to our Tarot Anthology *BEYOND DIVINATION: Spiritual Transformation through the Major Arcana* because it explains the spiritual message behind the symbology of the Major Arcana of the Tarot. Consequently, I will take this opportunity to sum up the importance of the teachings in examining card 9 – The Hermit. I will start with the card’s astrological connection to Mercury through the planetoid Chiron.



Before the discovery of the planetoid Chiron, Mercury ruled two sun-signs, Gemini and Virgo, with the former being assigned to card 6 – The Lovers and the latter card 9 – The Hermit. Today Mercury only rules Gemini, but it is still exalted (reaches its highest point) in Virgo. Both the planets, Mercury represented by card 1 – The Magician, and Venus represented by card 3 – The Empress, are depicted in The Lovers’ card, since the zodiacal sign assigned to it is Gemini - the twins. In Greek mythology Mercury is Hermes and he is often associated with Aphrodite (Venus), as in the association reflected in the word hermaphrodite meaning both male and female.

Material in our Tarot Anthology primarily echoes the original compilation of the Rider-Waite deck, because the *RT group* felt it was important to understand the information from the ancient perspective. For example, card 20 - Judgment is assigned to Vulcan as representing the element Fire. A.E. Waite developed the Rider-Waite Tarot deck in the late 19th (1800s) Century. At that time, metaphysicians believed the closest planet to the Sun was Vulcan. This belief held

sway until the discovery of Pluto (despite its recent demotion) in 1936, which replaced Vulcan in modern decks. Another example is that both card 1 - The Magician and card 9 - The Hermit, represent the Planet Mercury due to the latter representing the sun-sign Virgo, which Mercury (The Magician) is exalted in. With the discovery of the planetoid Chiron on November 1st, 1977, Virgo and therefore The Hermit became connected to Chiron. Have a great night, love always, Suzzan.



Post August 28th

Dear friends, today we can apply the Ancient Wisdom practically. One way is by adding the scientific aspect along with the mystical side of all the religions, including Valentinian Gnosticism, Kabbalistic Mystical Arts, Christian Mysticism, and Metaphysical Symbology, as well as Quantum Physics. For instance, the discovery of Chiron gave me a deeper understanding and importance to card 9 - The Hermit, because the card's Hebrew letter YOD, spelled in Hebrew IVD, means "Hand." From this perspective the importance of the Hebrew letter Yod involves several cards.

On the face of it, Yod does not appear that important as it is the sixth letter of the twelve Simple letters assigned to the twelve signs of the Zodiac. However, Yod denotes the will, not the same as the will of the Magician, but the Divine Will, which is also the Divine Spirit. To signify this, the Kabbalists designed the Yod to look like the flame of the foundation of all twenty-two Hebrew letters. Therefore, as the RT group says, the Yod "pictures the seed-thought of all the rest." Essentially, the remaining twenty-one letters only depict various forms of "growth", but Yod's "growth" produces a plant or tree containing 22 branches. They explain that the

message from the three Hebrew letters to construct Yod (IVD) or Yod – Vau – Daleth conveys that our bodies are transformed through the creative imagination of our individual subconscious (Daleth = Empress), which “links” through our Higher Self (Vau = Hierophant) to our Spirit (Yod = Hermit). Remembering that Hebrew is always written from right to left, the group reminds us that the meaning of Vau is “links.” In this way, the appearance of Yod in any letter is important. For instance, they tell us that the Hebrew letter Ayin (א -The Devil), contains two Yods ם (Spirit) and a Vau ן (Higher Self), which reveals a hidden value of 26 for Ayin,  $2 \times 10 + 6 = 26$ . Since this is the number for the tetragrammaton IHVH or Yahweh, it reveals a hidden message, as the Devil card symbolizes the physical body. Therefore, the secret message is that our bodies are the key to transformation, as at the spiritual level we are manifesting the “Law of Cycles.” In Ayin, the two Yods represent the spirit beneath the self-conscious and subconscious, meaning if we honor our bodies instead of abusing them, they will transform our self and subconsciousness into the Superconscious. However, the 15 Yellow Yods falling to the ground from the Sun in card 18 – The Moon, represent 15 conditions of consciousness signified by the Simple Letters of the 12 sun-signs and the 3 Mother Letters of the Hebrew Alphabet. The ground the Yods fall on being blue instead of green denotes that until a person unites their two subconsciousness, i.e., their Empress and High Priestess, he or she will not achieve all 15 conditions of consciousness that the Yods represent.



The 15 Yods, which stands for the 15 extensions of Consciousness, are represented by the 15-petaled rose on the pennant of Death. The Hierophant (Higher Self) wears a crown composed of them, which means that he had control of them. The Hierophant is the Masculine expression of The High Priestess. From the very beginning, the Universal Mother has been leading us up to the point where she can rain this influence upon us, patiently longing for the Self-Conscious to make it possible for Her so to transform the body. The letter Yod is assigned to card 9 The Hermit and Eliphas Levi referred to the number 9 as “the absolute number.” In the Kabbalistic system, the number 9 is associated to regeneration. It also indicates a new birth, going forth and voyaging. Can there be a finer description of The Fool

who becomes The Hermit. Yod is the Key to connecting The Hermit to both The Fool and Kether.

The piece de resistance is found in the fact that at the very heart of the mysterious Isiac Tablet, reproduced in Manly P Hall's Encyclopedia is IYNX, which represents the universal being. Eliphas Levi related that G.R.S. Mead said that according to Proclus the root meaning of IYNX is the power of transmission. Levi associated this with the Hebrew letter Yod in which he describes as, "that unique letter from which all other letters were formed." Next we look at the incredible examples of symbology in the nation's capital Washington DC. Have a great day, love always, Suzzan

Dear friends, earlier, I related that David Ovason's book, *THE SECRET ARCHITECTURE OF OUR NATION'S CAPITAL: The Mason's and the Building of Washington DC*, indicated that George Washington was carefully infusing specific Astrological influences into the founding of DC I believe I demonstrated that Mr. Ovason's book contains a veritable treasure of data to support his supposition, specifically, astrology's major role in the design of Washington DC Interestingly, I

found a curious comment to “the Car of History”, (which I believe is an important feature in the author’s hypothesis) in an article on the web site ASTROLOGY: WASHINGTON DC STAR IQ WEB SITE - concerning David Ovason’s book it reports: The first astrological reference in the capital was the Car of History, sculpted in 1819 for the Statuary Hall. Images of Sagittarius, Capricorn and Aquarius appear on the front of the winged chariot...

David Ovason and others attribute the inspiration for the Founding Fathers predilection to associating Washington DC with the constellation Virgo, to the Virgin Mary. However, the sculpture *Car of History* mentioned above, alludes to a different spiritual female figure, shedding light on how informed some of the Founding Fathers were in *The Ancient Mysteries*. It is interesting to note that although Washington DC was carefully aligned to Virgo, according to David Ovason, the first outward evidence of astrology does not appear until 1819 in the form of a sculpture by Carlo Franzoni, entitled the *Car of History* featuring the “Muse of History” Clio. He describes the statue in detail, relating that Clio is “standing in a winged chariot that is being drawn along spiritually – perhaps by its own wings, or perhaps by some invisible agency...” Clio’s left foot is “on the edge of the chariot” and she appears to be dispassionately gazing down at us, while writing down all that she observes “in a large book.” Within the chariot wheel is a clock face that “rests upon a segment of the zodiac”, suggesting that the Car of History stands outside the “ordinary stream of time” signified by the Sun’s journey through the 12 signs of the zodiac. The specific section of the zodiac has just 3 sun-signs “picked out in marble relief”, Sagittarius, Capricorn, and Aquarius.

In his book, David Ovason addresses the astrological influence behind the statue of the *Car of History*. Yet for me, it was his later connection of an engraving of the Universal Mother Goddess to Franzoni’s sculpture that is the most illuminating, as it reveals the spiritual relevance and determines the true message of this remarkable work of art. He writes that the “woman in the engraving”, who also represents Virgo, is reminiscent of the figure Clio in the *Car of History* situated on the rim of a zodiac. Seemingly, both figures represent Virgo in her role of “detaching herself from eternity to descend to the earthly plane.” In Clio’s case, this action involves “turning herself inside out.” Mr. Ovason explains, Clio’s “feet” are positioned on the segment of the zodiac in which Virgo’s opposite sign Pisces is located. Interestingly, Clio’s association with Pisces shows that she engages in a polarity shift in order “to emerge into time from eternity.” Mr. Ovason discloses that the purpose behind the *Car of History* is seen through the symbology in the sculpture. Here the zodiac denotes “eternity,” which along with Clio as the archetype of the Virgin in all her aspects, remains outside of linear time. However, in the statue Clio together with several sun-

signs “has wrenched herself free”, emerging from “the Archetypal world into the material realm.” Ultimately then, Mr. Ovason relates that Franzoni’s Clio lives between the two worlds of spirit and matter. She is compelled to observe as objectively as possible all that happens on the Earth Plane. The author has discovered that all this information is reflected symbolically on the “doorway in the Capitol leading towards its center.” He tells us that this doorway symbolizes “the notion of the center doorway, which penetrates the two worlds and permits ingress from the heavenly into the earthly. It is therefore equated with a door of life.”

Reading of the connection of time to the opposite sign to Virgo, Pisces, in David Ovason’s book reminded me of the Dendera Zodiac. I first learned of this mysterious artifact in a documentary concerning 2012, where Gregg Braden mentioned the Dendera Zodiac in reference to Fractal Time in his book *Fractal time: The Secret of 2012 and a New World Age*. Wikipedia’s entry for the Dendera Zodiac has some interesting information, such as it was found inside a temple to the goddess Hathor, as a bas relief on the ceiling of a “chapel dedicated to Osiris.” The consensus among experts is that the zodiac dates to around 50 B.C.E., because it contains “the stars and planets in the positions they would have been seen at that date.”

Displaying the twelve constellations, with their 36 decans of ten days, as well as the planets, it is “a planisphere or map of the stars on a plane projection.” According to the author of the entry, “These decans are groups of first-magnitude stars.” Moreover, the stars were known and “used in the ancient Egyptian calendar, which was based on lunar cycles of around 30 days and on the heliacal rising of the star Sothis (Sirius).”

Regarding the details on the Zodiac, the author tells us that there are “36 spirits” denoting the original 360 days of the Egyptian year on the first circle. Moving inwards, we find the traditional 12 signs or constellations. Although most reflect today’s sun-signs, they are “in odd orientations in comparison to the conventions of ancient Greece and later Arabic-Western developments), whilst others are shown in a more Egyptian form: Aquarius is represented as the flood god Hapy, holding two vases which gush water.”

Apparently, the Dendera Zodiac was discussed by Denon, a member of the Napoleonic expedition. After returning he “published engravings of the temple ceiling”, creating “a controversy as to the age of the zodiac representation, ranging from tens of thousands to a thousand years to a few hundred, and whether the zodiac was a planisphere or an astrological chart.” The zodiac remained in place until 1820,

when an “antiquities dealer Sébastien-Louis Saulnier commissioned Jean Baptiste Lelorraine, a master mason, to remove the circular zodiac...”

I found it particularly interesting that “a master mason” was involved in the removal of the Dendera Zodiac to France, because as David Ovason shows, masons, especially master masons were well-versed in astrology. Mr. Braden’s observations on the Dendera Zodiac led me to discover a deeper message hidden in this zodiac, especially when he pointed out that there was a disproportionate distance between Pisces and Aquarius. Scholars suggest that many philosophers and Hermeticists believe the constellation Ophiuchus lays between the sun-signs Sagittarius and Scorpio, and that the constellation is in direct line with the center of the galaxy. This is relevant because all the prophecies surrounding 2012 stressed the sun rising in exact alignment with the center of the galaxy on December 21, 2012. If, as I suspect Franzoni’s *Car of History* was also drawing our attention to the alignment, it suggests that some of the Founding Fathers of America also knew of the prophecy.

Anyway, to me it was clear that certain Founding Fathers were well versed in astrology, but why the obsession with the constellation Virgo? Earlier I related that aligning Washington DC to the constellation Virgo, had beneficial consequences. This was because with Mercury ruling Virgo at the time, after the discovery of Uranus (the higher octave of Mercury), the Consciousness of Melchizedek began guiding the new nation. Nonetheless, when Chiron replaced Mercury as the ruling planet of Virgo, the “*Light’s*” true ruler, The Universal Christ took over the spiritual guidance of America. Unfortunately, as I have alluded to throughout *Volume II*, long before Chiron’s discovery the “*Shadow*” inserted “his” influence in the New World. As the founding of America was so crucial to the spiritual development of Humanity, the “*Shadow’s*” ability to interfere had extremely severe repercussions right up to this very day. ### **Dendera Zodiac reconstructed**

According to its entry on Wikipedia “The sculptured Dendera zodiac is a widely known Egyptian bas-relief from the ceiling of the pronaos (or portico) of a chapel dedicated to Osiris in the Hathor temple at Dendera, containing images of Taurus (the bull) and Libra (the scales). This chapel was begun in the late Ptolemaic period; its pronaos was added by the emperor Tiberius. This led Jean-François Champollion to date the relief to the Greco-Roman period, but most of his contemporaries believed it to be of the New Kingdom.

“The relief, which John H. Rogers characterized as ‘the only complete map that we have of an ancient sky’, has been conjectured in the past to represent the basis on which later astronomy systems were based.” Apparently, it on “display at the *Musée du Louvre*, (Louvre Art Gallery and Museum) Paris.”

Dear friends, in reading David Ovason’s book, Craig and I were amazed at the sheer knowledge of some of America’s Founding Fathers. Even so, we were perplexed as to why the obvious astrological influences in Washington were played down and in effect ignored until now. Certain founders of America used symbology and sacred

geometry to energetically infuse the country spiritually, but unfortunately the “*Shadow*” influenced some individuals to effectively nullify much of their work, which was achieved in several ways. The first and most blatant victory was convincing the founders to adopt the eagle as America’s emblem.

I related in *Part One Volume I* my dilemma over the influence of the eagle in the world. Again, I discovered that although Aquila was thought to be the eagle representing Scorpio and one of the four corners in card 10 - The Wheel of Fortune, and card 21 - The World, this was a smokescreen. So, before I address the ramifications of using the eagle as an emblem for America, I will recap the most relevant excerpts that I recorded concerning connecting the constellation Aquila to a Greek myth.

To reiterate: Aquila, together with other constellations in the Zodiac sign of Sagittarius may be a significant part of the origin of the myth of the Stymphalian birds. It could also have originated from the eagle Ethon, the tormentor of Prometheus. Ethon or the Eagle Kaukasios was a gigantic eagle born of the monsters Typhon and Echidna. In Greek mythology, the Stymphalian birds were man-eating birds with claws of brass and sharp metallic feathers they could launch at their victims, with highly toxic dung. They were also the god Ares’ pets.

As I said in *Part One*, the mention of Typhon alerted me to a title for the *World Soul*. Lest we forget, this was the original name for the “*Shadow*” in *Globe C*, prior to “his” descent into the Earth Plane as the “*prince of this world*” in the Common Era, on *Globe D*. Having found no positive associations with either Aquila or the eagle, the common assessment that Aquila represented the raised sex force seemed wrong to me. Nonetheless, as I wrote “that may be a too strong a statement, as the energy of Spiritual Evolution is a great deal more complicated. It was important for me to remember that the Astrological energy is dual, for example as Scorpio is opposite Taurus, the Astrological energy of Scorpio can be used either for the Higher Self or the lower instincts. The plan is to use the passions to help Humanity transmute the emotions and lower instincts.”

A key reason for the Founding Fathers obsession with the constellation Virgo was to set the scene for the discovery of Chiron, but that is only one of the reasons. The other reason concerns the connection with the Divine Feminine. By literally reflecting the constellation Virgo in the layout of their buildings, the architects of America were inviting the beneficent energies of the Divine Feminine to guide the fledgling nation. Regrettably, as the United States was already under the influence of Mercury, through its affiliation with the sun-sign Gemini, adding the influence of

Virgo opened the country up to dualism. Certain founders of America as expert astrologers were obviously aware of this and consequently took pains to bring balance. This is the reason why they seeded their buildings with the plant of life in their Masonic cornerstone/foundation stone rituals and placed multiple symbols of the plant of life on their buildings. Unfortunately, the “*Shadow*” was also aware of this potential “problem” and moved to take full advantage of it. Due to the duality of the Soul Plane, each astrological sign possesses dual energies, one influenced towards the higher or spiritual and one influenced towards the material or lower.

The first problem the “*Shadow*” needed to overcome was the Masonic influence, as most of the Founding Fathers were members of the “*Orders of the Quest*”, which meant the Freemasons in America were operating as representatives of the “*Light*.” George Washington and Benjamin Franklin were the real thorns in the “*Shadow’s*” proverbial side, and while they were alive “he” could do nothing about it. That changed at the end of the 18th century (1700s) when both Washington and Franklin died, and the “*Light’s*” influence was weakened. This weakening continued over the first half of the 19th century until the mid-19th century, when all the Founding Fathers were dead. Then the “*Shadow*” made “his” move.

To get an understanding of the atmosphere of America in the first half of the 19th century, as stated, I turned to Alexis de Tocqueville’s *Democracy in America*. Although the copy I have was published in 1964, de Tocqueville wrote the book between 1835 and 1840, and so, his perspective of America is therefore as an objective observer rather than as a historian.

Investigating the founding of America, I wondered if the Founding Fathers envisioned a Capitalistic Society when they signed the Declaration of Independence. After all, the American Revolution was fought to reject being governed by privilege or the elites, as in the British monarch King George (III). However, King Charles (II) gave the “*Carolinas to eight nobles*” to divide amongst themselves. This corrupted the energy, which we see in the wealthy landowners adopting the attitude of dividing the country after the American Revolution. As a result, most of the population, i.e., the working class, ended up working for the minority, the upper class.

Today Britain benefits from a socialistic democracy, which as I said, was designed to ensure that “everyone had the essentials of life.” This system is financed by taxes, with those that have more paying higher taxes. To reiterate, contrary to some popular misconceptions, a socialistic democracy is not the same as the former Soviet Union, or Chinese Communism. Individuals can and do aspire to wealth and success, which

is proven by the many wealthy individuals in the UK. Yet, the wealthy willingly pay a higher percentage of their income to ensure that everyone has healthcare, education and is taken care of when they are old.

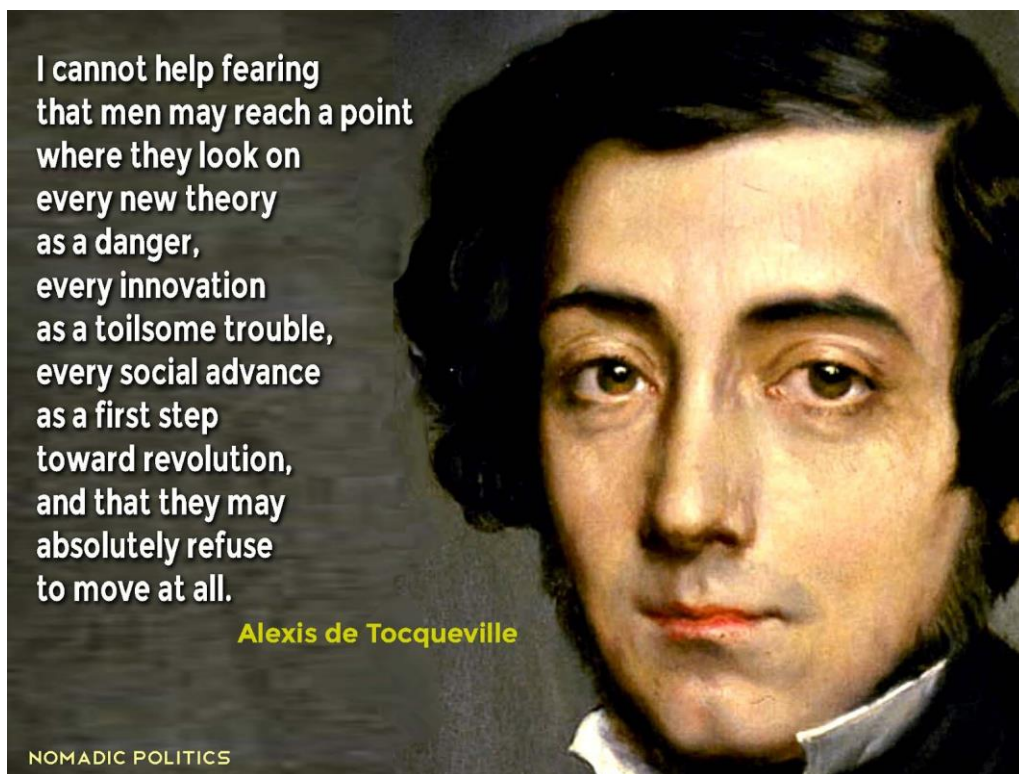
My question was, “what exactly did the Founding Fathers or rather the “*Orders of the Quest*” have in mind for America?” The Constitution asserts that everyone is equal, and that America would be a nation ruled by the people, the same premise that socialism is founded on. Capitalism on the other hand, appears to replace the aristocracy with a rich and privileged minority. True, anyone can become a “member” of this class, because who joins is determined by the amount of money an individual has. Nonetheless, from a spiritual perspective, the Founding Fathers as members of the “*Orders of the Quest*” would have never encouraged such a system, simply because it would be detrimental to the spiritual evolution of the individual.

In considering the above conclusion, I needed to know how America developed after their guiding “lights” were extinguished. De Tocqueville’s observations on the pitfalls of democracy, were to say the least, enlightening. He observes that although the president, “possesses almost royal prerogatives” outwardly, in reality the system of government often ties his hands. This was never more evident than in the modern political system, where the opposition party’s sole goal seems to be to subvert the president’s agenda at all costs.

De Tocqueville relates that destructive “passions” to a country’s progress “increase” exponentially with the size of a nation, whereas the “virtues” that benefit the nation are not increased “in the same proportion.” This is evinced by the “ambition of private citizens”, which grows “with the power of the state.” One of the safeguards, “the love of country” would ordinarily curb these ambitions”, but alas, in a “large republic” it is not only no “stronger” than a smaller country but can be shown to be “less powerful and less developed.” He continues, “Great wealth and extreme poverty, capital cities of large size, a lax morality, selfishness, and antagonism of interests, are the dangers which almost invariably arise from the magnitude of states...”

As worrisome as de Tocqueville’s observations on the citizenry of a “large republic” are, I was more perturbed by his warnings about political parties. He writes that on the political front in a large “republic”, the “passions become irresistible.” This is not just because of grand schemes and ideas, but because of the synchronicity of these same wishes being “felt and shared by millions of men at the same time.”

Considering this treatise premise, de Tocqueville's observations demonstrate his understanding of the mass consciousness (Mind-Stuff) subliminally acting in unison. Ultimately, he thinks this kind of synchronized thinking within "great republics" is extremely detrimental "to the well-being and the freedom of men." De Tocqueville concludes with the observation that "the desire of power is more intense in these communities than amongst ordinary men... love of glory is also more developed in the hearts of certain citizens, who regard the applause of a great people as a reward worthy of their exertions, and an elevating encouragement to man..." Next we see how America's national symbol was influenced by the "Shadow." Have a Great night, love always, Suzzan.

Dear friends, examining how the "Shadow's" determination to manipulate the founding of New Jerusalem (America), obviously, the Founding Fathers ("Orders of the Quest") were aware of the dangers to the spiritual well-being of the citizens of America. Again, I believe it is the reason they took such pains to ensure the correct spiritual energy was infused into the capital city. Above I said that the "Shadow" had to wait until the mid-19th (1800s) century to begin nullifying the "Light's"

objective. Persuading the adoption of “his” symbol the eagle, was only the first of many moves “he” made.

If the above statement seems too strong, consider what regimes and empires have used the eagle for their emblem, starting with the Roman Empire, whose citizens considered watching the torture and murder of hundreds of people entertainment or sport. Moving to the Middle-Ages, we find an eagle representing the Hapsburg Empire hovering menacingly over the scenes of multiple paintings. Lest we forget the Hapsburgs were sponsors of the Spanish Inquisition, the annihilation of the Incan and Aztec civilizations, and the cause of repression and tyranny throughout Europe and the world for centuries. Nevertheless, to me the clearest example of the eagle as the symbol for the “*Shadow*” is that Adolph Hitler, the embodiment of the “*prince of this world*” used the eagle as the symbol of his Fascist regime, the Third Reich. That said, the one saving grace was that all of the regimes above used the Golden Eagle as their symbol, whereas as we know America has the Bald Eagle as its symbol. So, although, both are eagles, America’s symbol was more neutral and could be adapted by other symbology.

With the adoption of “his” symbol, the next step in the “*Shadow’s*” scheme was to make America all about the individual instead of a collective whole working for the benefit of all. “He” achieved this very cunningly with the “Bill of Rights”, which I touched on earlier. Again, I must reiterate that this is not a political statement, but rather an observation of the energy and consciousness it caused. Looking objectively and dispassionately at this document, we can see that it completely contradicts the goal of Spiritual Evolution. I am not saying that all amendments are opposed to spiritual progress. For instance, the First Amendment meant the end of burning books that disagreed with conventional thought. Nonetheless, the First Amendment is neutral and can be used by both the “*Light*” and the “*Shadow*”, for example, the “*Shadow*” used it to foster hatred between different factions by the publication of politically charged literature. Regrettably, although not all the Bill of Rights is opposed to spiritual progress, some amendments are purely beneficial to the “*Shadow’s*” agenda. The perfect example is the Second Amendment granting all citizens of the US the right to bear arms. With its enactment, we have seen, and are continuing to see daily how the “*Shadow*” used this amendment to spread fear and chaos.

The next targets for the “*Shadow*” were the very forces of the “*Light*” that founded America and their carefully crafted spiritual structure. It is important to always keep in mind that the US was the result of a nearly 2 millennia plan to preserve the wisdom and knowledge of how to implement *The Mysteries* spoken of by Jesus, at least until

the 20th century. Some key people in the process, were the Gnostics, predominantly the disciples St. Mary Magdalene and St. Thomas. Later the Apostle Paul passed *The Mysteries* on through his disciple Theudas who then taught Valentinus. These teachings, as stated, were preserved in the *Nag Hammadi Library* that was discovered in 1945. In the Middle Ages, Bards and Minstrels spread the teachings through Romantic Chivalry, as in the search for the Holy Grail. This knowledge was then passed through the “*Orders of the Quest*” to the Knights Templars, who created living buildings of *The Mysteries* in the great Gothic Cathedrals. During the Renaissance, artists, such as Leonardo DaVinci, Michelangelo, and Bernini, together with Nostradamus and the Rosicrucians carried *The Mysteries* forward in symbols and colors. Sacred Geometry, a key component in the building of the Cathedrals involved the Masons, which after the mass execution of the Templars took the knowledge to Scotland and Rosslyn Chapel. As stated, because of Jacques de Molay’s curse, some of the inheritors of the knowledge became corrupted and so they divided, with the pure stream of Freemasons from Scotland determined to build a New Jerusalem in the Promised Land of America.

As America was under the dual influence of Gemini, the Founding Fathers or “*Orders of the Quest*” knew they had to safeguard against the “*Shadow*” side of the sun-sign Gemini. Therefore, they made sure that Washington DC was built under the beneficent influence of the constellation Virgo.

Lamentably, the “*Shadow’s*” next move was to nullify the carefully crafted Virgoian influence, by breaking the connection to the city. How “he” achieved this was simply genius. I know that I have already covered a lot of this, but it is so critical to understanding how America’s Destiny was hijacked that I am going to repeat it.

David Ovason’s book, *The Secret Architecture of our Nation’s Capital* demonstrates that Washington DC was carefully planned and laid out to reflect the constellation Virgo. Like I reported, the Federal Triangle mirrored the three major stars Spica, Regulus, and Arcturus of Virgo on the earth plane through connecting the Capitol, White House, and Washington Monument in the pattern of the constellation. This meant that these three edifices needed to be in direct line of sight to one another, and as we know, until Andrew Jackson’s presidency that was the case. There was more than one affect caused by mirroring the skies on the material plane, but one was to assist in building a democracy. Mr. Ovason explains that L’Enfant’s map made certain that the legislative branch of government (Congress) could “keep an eye”, on the executive branch (president) and vice a versa. Spiritually, this would mean that Spica and Arcturus could watch over the “little king” Regulus in residence at the

White House. Today, as I have repeatedly said, this vista is obscured by the Treasury Building, whose location was determined by Andrew Jackson in 1836.

Locating the Treasury Building between the Capitol and the White House was far more serious from the spiritual perspective, than Mr. Ovason states. Still, before I reiterate my interpretation of the seriousness of Andrew Jackson's decision, I will restate what David Ovason interprets as *the Mystery of Washington DC*. Our author relates this "secret" is uncovered in the orientation of Pennsylvania Avenue <sup>4</sup>, together with the proficiency of L'Enfant's partner Andrew Ellicott in astronomy and surveying. Apparently, Ellicott was considered the "best" in America at the time. This fact caused Mr. Ovason to ask why Ellicott laid Pennsylvania Avenue out in such a way that "it's central portion, between Capitol and White House ran at an angle different from the rest?" Mr. Ovason's brilliant detective work was able to answer his own question, by determining that the angle was to point to a specific "sunset."

In a nutshell then, the relevant sunset was that of August 10, because of the brightness of the star Regulus. On this specific evening a remarkable phenomenon takes place. Immediately after sunset an "inverted triangle" of the three stars surrounding Virgo, Spica, Arcturus, and Regulus appears over Pennsylvania Avenue. The significance is that as Mr. Ovason writes, "This symbolism pulls together the images of the triangle, the corn, the cornucopia, the zodiac and the refulgent image of the Virgin, in all her diverse forms." He observes how the mystery schools of Egypt, Greece, and Rome incorporated all these symbols. Not to mention that because of the precession of the equinoxes, the star Regulus has been moving higher in the sky, meaning that it remains "above the horizon" for just a little longer each year. Ultimately this allows for a greater chance of all three first-magnitude stars becoming a "visible part of the great cosmic triangle." Mr. Ovason believes that the appearance of this "great triangle" will become more and more powerful.

It was through David Ovason's book that I understood how the "*Shadow*" corrupted the "*Light's*" objective for America. As when President Jackson chose the site for the Treasury Building, he not only blocked the "reciprocal view" between the Capitol and the White House, but completely altered the energy and consciousness of the American Government. To understand what I mean, it is necessary to switch from literal thinking to viewing the situation from the spiritual perspective. The "*Orders of the Quest*" were guided to build a country that would promote spiritual advancement, necessitating a shift from focusing on self-interest to focusing on the greater good for all. Placing a building that clearly represents material wealth in such a prominent position, infused the governing consciousness with self-interest and

opened the door to corruption. Again, I am not pointing fingers at any specific individuals, because the “*Shadow*” was able to influence anyone who had not addressed their human ego. Nonetheless, the “*Light*” did not sit still and allow the “*Shadow*” all “his” own way, because before the Treasury Building was built, they took measures to transfer the consciousness to another location.
